


Extra Trash Pick Up

ORDINANCE UPDATE

UTILITY BILL LATE FEE

Utility Bill Late Fee Changes

As per our new city ordinance, utility bills will be considered delinquent if not paid **30 days after the billing date**. Authorized interest and penalty charges will start accruing on this date, including a \$20.00 late fee. Delinquent notices will be mailed on, or shortly after the 31st day *after* the billing date. If the bill remains unpaid 45 days after the billing date, all utility services will be discontinued. To restore services, the total balance due *plus* a \$30.00 water turn on fee must be paid.
