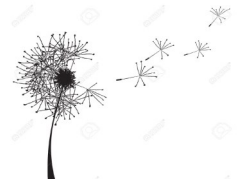

SPRING IS HERE!

AND SO ARE

THE WEEDS



You have seen it. We've seen it. Everyone's seen it. High grass and weeds in the yards and vacant lots. Not only are they unsightly eyesores in our Town, but they pose a fire hazard, block visibility for drivers, contribute to allergies, harbor rodents and snakes, and contribute to bugs and other pests. Spring is the best time to kill weeds.

The Town of Mills Municipal Code states that the owner/occupant/agent is responsible for maintaining their yards and vacant lots. The Town Code also states that they must maintain the streets, sidewalks and alleyways abutting thereon, free and clear of weeds, noxious vegetable growth and any vegetation which constitutes a fire hazard.

The sidewalks are also to remain clear of debris, to include gravel.

To stay within the Code, keep your yards and vacant lots mowed and clear of weeds. If the Code Enforcement Officer finds an overgrowth of grass/weeds on your property, you will receive a posted notice (once per year) and will have **10 days** to mow it. If not completed within the 10 days, a citation will be issued which carries a fine up to **\$750.00**.

****REMINDER**** — Water billings are mailed out the 1st of every month and due by the end of that month. You are allowed a 15 day grace period into the following month before a \$20.00 penalty fee is assessed and your water is turned off. If you are unable to pay on time, you must contact us before the 15th to make payment arrangements. Payment arrangements are not accepted once the fee is assessed.

Mayor and Council opted to not shut water off for non-payment from March thru June in light of COVID-19. Beginning July 15th any accounts that are past due will be shut off. If your account is past due and you need to make payment arrangements, please contact Town Hall and speak with the Town Clerk prior to July 15th.
