Thereupon Councilman Schimpf introduced and there was read at length the following Ordinance entitled:

#### ORDINANCE NO. 117

AN ORDINANCE PROVIDING FOR THE SUBMISSION TO A VOTE OF THE QUALIFIED ELECTORS OF THE TOWN OF MILLS, AT A SPECIAL ELECTION TO BE HELD IN SAID TOWN ON MAY 14, 1957, THE QUESTION OF AUTHORIZING SAID TOWN TO BORROW MONEY AND ISSUE ITS SEWER REVENUE BONDS IN AN AMOUNT NOT EXCEEDING \$175,000 FOR THE PURPOSE OF PAYING THE COST OF CONSTRUCTING A SEWERAGE SYSTEM FOR SAID TOWN AND ITS INHABITANTS.

WHEREAS, the Town of Mills, Wyoming, does not have a proper or adequate sewerage system; and

WHEREAS, in the opinion of the Town Council it is necessary to construct a sewerage system for said Town and its inhabitants, such system to consist of mains, laterals, a sewage disposal plant or oxidation pond and necessary appurtenances: and

WHEREAS, the Town does not have in its treasury available funds which may be used for said purpose, which fact makes it necessary to submit to the qualified electors of the Town the question of incurring indebtedness and issuing bonds for said purpose:

THEREFORE, BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF MILLS, WYOMING:

Section 1. That at a special election of the qualified electors of the said Town of Mills in the County of Natrona, and State of Wyoming, to be held on Tuesday, the 14th day of May, A. D. 1957, there shall be, and there is hereby submitted to the qualified electors of said Town the question and proposition stated in the form of ballot and proclamation hereinafter set forth.

Section 2. That the question and proposition so submitted shall be voted on at said election by the voters qualified by law at <u>Special</u>

<u>Election held in New Municipal Building</u> in said Town.

Section 3. Said election shall be held and conducted and the vote canvassed and returned and the result declared in the namer prescribed by law for other form elections. On the day of said election, the voting place shall be opened at nine o'clock in the morning and it shall be kept open without any adjournment until seven o'clock in the evening, at which time the voting place shall be closed.

Section 4. At said election there shall be provided two ballot boxes at the polling place, one to be designated ballot box "A" and the other ballot box "B". There shall also be provided two sets of ballots, one of which shall be printed on white paper and the other on colored paper both of which shall contain the same statement of the proposal to be voted upon and the same instructions respecting the manner of marking the ballot.

revenue bonds is carried at said election, the Town Council will adopt a supplemental ordinance setting forth the terms and conditions under which said bonds shall be issued.

Section 10. All ordinances, or parts of ordinances, in conflict with this ordinance are hereby repealed.

Section 11. Because of the fact that the Town is not properly or adequately supplied with sewer facilities, the Town Council finds and declared that an emergency exists; that this ordinance is for the immediate preservation of the public peace, health, and safety and shall be in full force and effect from and after its passage and approval.

D. 1957, at which election there was submitted to the qualified electors of said Town the question of issuing Sewer Revenue Bonds of said Town in the sum of \$175,000; that the polling place was opened at the hour of 9:00 o'clock a.m., and it was kept continuously open until the hour of 7:00 o'clock p.m. on said date; that at said election two ballot boxes and two sets of ballots were used; that in ballot box "A" the general electors of said Town, possessing the qualifications specified in Ordinance No. 117 of said Town, were permitted to deposit their ballots printed on white paper; that in ballot box "B" electors who were the owners of or the spouses of the owners of real or personal property on the assessment rolls of said Town, deposited their ballots printed on colored paper; that before any person was permitted to vote a ballot printed on colored paper, he or she was required to make before the officers of election, an affidavit showing that he or she was the owner of or the spouse of the owner of real or personal property assessed on the assessment rolls of said Town: that the ballots used at said election were in the form prescribed by said Ordinance No. 117; that immediately after the closing of the polls the votes contained in each of said ballot boxes were duly counted and canvassed; that in Ballot Box "A", there were cast 3/ ballots for Sewer Revenue Bonds and / ballots against Sewer Revenue Bonds; that in Ballot Box "B" there were cast [2] ballots for Sewer Revenue Bonds and 66 ballots against Sewer Revenue Bonds; and that the results disclosed by such canvass are hereby certified to the Town Council of the Town of Mills, Wyoming.
