

ORDINANCE NO. 127-B

AN ORDINANCE TO AMEND AND RE-ENACT SECTION 3 OF ORDINANCE  
NUMBER 127 WHICH AMENDED AND RE-ENACTED SECTION 19 OF ORDINANCE  
NUMBER 99..

BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE TOWN OF MILLS, WYOMING.

SECTION 1. That Section 3 of Ordinance Number 127, which amended Section 19 of Ordinance Number 99, be amended and re-enacted as follows:

Section 19. MONTHLY CHARGES FOR SEWERAGE SERVICE. That charges for sewerage service within the corporate limits of the Town of Mills shall be imposed or assessed against each user of such service, shall be in the sum of Twelve (\$12.00) dollars per quarter-year, said charge to be the minimum charge and based upon the use of 9,000 gallons of water per quarter, each user that uses in excess of 9,000 gallons per quarter, shall be charged the minimum charge plus five (5¢) cents for each 1,000 gallons used in excess of 9,000 gallons for each quarter, provided further, that the sewerage charge for the second, third, and fourth quarters of each year (April 1st through December 31st) shall be the same as billed for the first quarter of the year; users that were not billed during the first quarter of the calendar year shall pay the charges set out above; the charges for sewerage service outside the corporate limits of the Town of Mills shall be in the sum of Twenty-four (\$24.00) dollars per quarter-year, said charge to be the minimum charge and based upon the use of 9,000 gallons of water per quarter, each user that uses in excess of 9,000 gallons per quarter shall be charged the minimum charge plus ten (10¢) cents for each 1,000 gallons used in excess of 9,000 gallons for each quarter.

SECTION 2. That this Ordinance shall take effect and become in force from and after its being posted for a period of ten days as required by law.
