

ORDINANCE NUMBER 128

THE ANNUAL APPROPRIATION ORDINANCE FOR THE NEW FISCAL YEAR BEGINNING
MARCH 1, 1961, AND ENDING FEBRUARY 28, 1962.

BE IT ORDAINED BY THE TOWN COUNCIL TO THE TOWN OF MILLS, WYOMING:

SECTION 1. UNEXPENDED MONEYS TO REVERT TO GENERAL FUND. That all moneys hereby appropriated, but remaining unexpended at the end of the fiscal year for which this appropriation is made, shall revert to the general fund of the Town and shall be subject to subsequent appropriation.

SECTION 2. STATED ESTIMATE OF AVAILABLE ASSETS. That the present and anticipated assests of the Town of Mills, from which the herein provided appropriated moneys are to be disbursed during the course of the year, are hereby stated to be approximately as follows:
