

ORDINANCE NO. 130-A

ORDINANCE TO AMEND AND RE-ENACT SECTION 73 OF
ORDINANCE NUMBERED 130 PERTAINING TO PENALTIES.

BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE TOWN
OF MILLS, WYOMING.

Section 1. That Section 73 of Ordinance No. 130 be
amended and re-enacted as follows:

SECTION 73. - - - PENALTIES - - - Any person
violating Section 18 of this ordinance shall
be guilty of a misdemeanor and upon conviction
thereof shall be fined not less than \$15.00
nor more than \$100.00. Any person violating
Section 28 of this ordinance shall be guilty
of a misdemeanor and upon conviction thereof
shall be fined not less than \$5.00 nor more than
\$100.00. Any person violating Section 45 of
this ordinance shall be guilty of a misdemeanor
and upon conviction thereof shall be fined in
a sum of not less than \$5.00 nor more than
\$100.00. Any person violating Section 46 of
this ordinance shall be guilty of a misdemeanor
and upon conviction thereof shall be fined in
a sum of not less than \$2.00 nor more than
\$100.00. Any person violating any provision
of this ordinance, a penalty for which is not
heretofore provided, or any rule or regulation
made by the town Marshall pursuant thereto shall
be guilty of a misdemeanor and upon conviction
thereof shall be fined in any sum not exceeding
\$100.00.

SECTION 2. That this ordinance shall take effect
and become in force from and after its being posted for a
period of ten days as required by law.
