ORDINANCE NO. 194

WHEREAS on or about the 8th day of June, 1962, Martin Bertagnole, Scott Bertagnole, Joseph W. Bertagnole, and Leland F. Bertagnole, doing business as Millview Investment Co., a partnership, presented a petition to the Mayor and Town Council of the Town of Mills, Wyoming, for the annexation to the Town of Mills, Wyoming, of a certain tract hereinafter particularly described, and for the inclusion of said tract within the corporate limits of said Town of Mills;

AND WHEREAS in accordance with Section 15-365. Wyoming Compiled Statutes of 1957, the Town Council of the Town of Mills did cause a notice to be published of the filing of such petition, giving the number of names of the petitioners and description of the proposed addition, and setting a date not more than 30 days after the last publication of said notice, for a public hearing upon said petition, at a regular meeting of the Town Council of the said Town of Mills, and which said notice was duly published in a newspaper of Natrona County, Wyoming, once each week for three consecutive weeks, and as aforesaid, gave notice of a public hearing upon said petition, at a regular meeting of the Town Council of said Town of Mills on the 6th day of July, 1962, at the hour of 7:30 o'clock p.m. at the Town Hall of the Town of Mills;

AND WHEREAS, at the time and place appointed, to-wit, 7:30 p.m. on the 6th day of July, 1962, in the Town Hall, Town of Mills, for the said public hearing before the Town Council of the said Town of Mills, no protests or objection to said petition were made, presented, or heard;

AND WHEREAS, at said public hearing upon said petition, the Town Council of the Town of Mills did determine that the said petition should be granted, and that the said proposed addition should thereupon be included within the Town of Mills, County of Natrona, and the Mayor and Town Clerk accordingly were authorized to do all things necessary to effectuate said determination:

NOW, THEREFORE, BE IT ORDAINED by the Mayor and  
Town Council of the Town of Mills that the petition for the annexation of  
that certain tract described as follows:

A tract of land in the SE $\frac{1}{4}$ NE $\frac{1}{4}$ , Section 12, T. 33N.,  
R. 80 W., of the 6th P.M. Natrona County, Wyoming,  
more particularly described as follows:

The point of beginning is referenced to the NE corner  
of the SE $\frac{1}{4}$ NE $\frac{1}{4}$ , Section 12, T. 33N., R. 80 W.,  
Sixth Principal Meridian, by the following traverse:  
From said NE corner SE $\frac{1}{4}$ NE $\frac{1}{4}$ , S. 0° 18' W. a distance  
of 200 feet to the point of beginning.

From said point of beginning S. 89°29' W. along the  
southerly line of an existing 20' easement a distance  
of 497.73 feet to a point, said point being on the east  
boundary of the U.S.B.R. tract; thence S. 6°31' E.  
along said line a distance of 100.00 feet to a point;  
thence N. 89°29' E. a distance of 496.31 feet to a  
point, said point being an intersection with the east  
line of the SE $\frac{1}{4}$ NE $\frac{1}{4}$ , Section 12, T. 33 N., R. 80 W.,  
6th P.M.; Thence N. 0°18' E. along said line a distance  
of 100 feet to the point of beginning. Said lands  
containing 0.91 acres, more or less,

be and the same hereby is granted and allowed, and that the said tract  
be and hereby is included and made a part of said Town of Mills, and to  
be known and described as Tract A. Reclamation Center Addition to the  
Town of Mills, Natrona County, Wyoming; and

BE IT FURTHER ORDAINED, that the Mayor and Town  
Clerk of the said Town of Mills be and they hereby are ordered, directed  
and empowered to cause to be prepared and to be filed in the office of the  
Register of Deeds in the County of Natrona, a plat showing the boundaries  
of the said tract so added to the said Town of Mills.
