

ORDINANCE NO. 153

AN ORDINANCE TO AMEND AND RE-ENACT SECTION 19 of ORDINANCE NO. 99, AND TO REPEAL SECTION 3 OF ORDINANCE NO. 127, SECTION 1 OF ORDINANCE NO. 127-A AND SECTION 1 OF ORDINANCE NO. 127-B. ALL OF SAID ORDINANCES DEALING WITH MONTHLY SEWER CHARGES.

BE IT ORDAINED BY THE GOVERNING BODY OF THE TOWN OF MILLS, WYOMING:

SECTION 1. That Section 19 of Ordinance No. 99 be amended and re-enacted as follows:

SECTION 19. MONTHLY CHARGES FOR SEWER SERVICE.

(a) That charges for sewer service for one family units being served by an individual sewer hookup shall be Twelve Dollars (\$12.00) per quarter-year.

(b) Charges for sewer service for more than one family units or single family units who are sharing a sewer hookup with another family unit shall be Twelve Dollars (\$12.00) per quarter year, said charge to be the minimum charge and based upon Nine Thousand (9,000) gallons of water per quarter-year. Each of the multiple users that use in excess of 9,000 gallons per quarter-year shall be charged the minimum charge plus five cents (5¢) for each One Thousand (1,000) gallons used in excess of each 9,000 gallons per quarter-year. Provided further that the sewerage charge for the Second, Third and Fourth quarter of each year, (April 1st through December 31st) shall be the same as billed for the first quarter year; users that were not billed during the first quarter-year shall pay the charge set out above; charges for domestic sewerage service outside the corporate limits of the Town of Mills, shall be in the sum of Twenty Four Dollars (\$24.00) per quarter-year, said charge to be the minimum charge and based upon the use of Nine Thousand (9,000) gallons of water per quarter-year; each user that uses in excess of 9,000 gallons per quarter-year shall be charged the minimum charge, plus ten cents (10¢) for each one thousand (1,000) gallons used in excess of 9,000 gallons for each quarter-year.

(c) That charges for sewer service within the corporate limits of the Town of Mills for trailer courts having ten or more trailers shall be charged upon the rate set out above in paragraph (b), except that the charges shall be computed on water actually used each quarter-year.

(d) The charges for sewerage service for commercial establishments within the corporate limits of the Town of Mills shall be computed on the rates set out in paragraph (b) above, but the charges will be computed on water actually used each quarter-year.
