ORDINANCE NO. 161

AN ORDINANCE REGULATING INSTALLATION OF ELECTRIC WIRING AND APPLIANCES; PROVIDING A SCHEDULE OF FEES FOR INSPECTIONS; PROVIDING FOR THE ISSUANCE OF PERMITS FOR ELECTRIC WIRING; PROVIDING FOR CREATION OF THE POSITION OF TOWN ELECTRICAL INSPECTOR AND SPECIFYING THE DUTIES THEREOF; ADOPTING THE PROVISIONS OF THE NATIONAL ELECTRICAL CODE, 1965 EDITION; AUTHORIZING THE BUILDING INSPECTOR TO ACT AS ELECTRICAL INSPECTOR; REPEALING ORDINANCES NUMBERED 89, 89-A AND ALL OTHER ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT HEREWITH.

BE IT ORDAINED BY THE GOVERNING BODY OF THE TOWN OF MILLS, WYOMING.

SECTION 1. PERMIT REQUIRED. That all companies, firm, copartnerships, corporations or individuals who desire to have electric wiring, electric fixtures, appliances or apparatus installed in or on any buildings or property, or removed from the interior or exterior of any building or property (except central station power houses or substations belonging to companies operating under a franchise, and with the exception of wiring installed by companies operating under Federal, State or Town Franchise or regulation in the telephone, telegraph, railroad and radio and television transmission industries), shall procure a permit from the Town Electrical Inspector. It shall be unlawful for all contractors, workmen or individuals (not having applied for a permit for wiring) to in any way interfere with any electric wiring in, or on, any building or property in any manner whatsoever. A permit for private work is defined in Section 12.

SECTION 2. DEFINITION. That the term "electric wiring" herein used is intended to mean the fixed installation of electrical wires, appliances, fixtures or apparatus which are energized by twelve (12) volts or over, used or to be used or to be maintained, on or in any building or property for electric light, heat or power, electric sign, fire alarms, burglar alarms, electric bells, electric signal systems, telegraph messenger call systems, lighting fixtures or electrical apparatuses of any kind or description, with the exceptions hereinabove noted, and is not intended to include portable appliances, fixtures or apparatuses which are defined as appliances, fixtures, or apparatuses capable of being readily moved where established practices or the condition of use make it necessary or convenient for it to be detached from its source of current by means of flexible cord and attachment plug, automotive equipment and sound-recording and similar equipment as defined by Articles 640 and 810 National Electrical Code.

SECTION 3. CREATION OF OFFICE OF ELECTRICAL INSPECTOR. There is hereby created the Office of Electrical Inspector. The person chosen to fill the office of Electrical Inspector shall be a competent electrician; shall have had at least four (4) years experience as a wireman or electrical contractor and shall pass an examination prepared by the Mountain States Inspection Bureau and/or other

competent authority. Examination shall be given by the Town Engineer or any Examiner approved by the Town Council, and passing grade shall be 75%.

Said Electrical Inspector shall be appointed by the Mayor.

SECTION 4. DUTIES AND AUTHORITY OF INSPECTOR. The Electrical Inspector is hereby authorized to enter any building, dwelling, or structure (at reasonable times and by presenting the proper credentials) in which electrical work of either new construction, or additions to the existing electrical system is being made, which requires a permit or for which a permit has been granted. This right of entry is for the purpose of inspection of electrical work in progress or upon its completion. The Electrical Inspector is hereby authorized and directed to enforce all the provisions of this Ordinance, and for such purpose shall have the power of a police officer.

- A. AUTHORITY OF INSPECTOR TO REFUSE TO ISSUE CERTIFICATE. The Town

 Electrical Inspector is hereby given the authority to refuse to issue a Certificate for any addition or extension to any wiring system in or on any building or property where, in his estimation, the wiring is in an unsafe condition. In case the work does not comply with the Ordinance and the National Electric Code, he shall issue a written statement within twenty-four (24) hours as to the changes necessary to bring the work up to standard.
- B. CONDEMNED DEFECTIVE WIRING. Whenever any electrical wire or other piece of electrical apparatus is or shall become defective, by reason of improper or insufficient insulation, or for any other cause become dangerous, the said Town Electrical Inspector shall at once notify the owner, or the agent of the owner of said electrical apparatus to repair or remove the same, and upon the owner's failure to repair or remove the wire or apparatus within a reasonable time, the said Town Electrical Inspector shall cause the turning off of all electrical current.
- C. ELECTRIC PLANT INSPECTION. That it shall be the duty of the Town Electrical Inspector to inspect all private and isolated electric plants (exclusive of public utility corporation plants) now in operation in the Town or hereafter installed, once in each year or more often, and he shall see that any dangerous or defective machinery, wires or appliances are removed or remedied immediately at the expense of said agent or owner.
- D. ACTION IN CASE OF FIRE. That every company, firm, copartnership or individual owning or controlling electrical wires and apparatus for the transmission of light, heat or power shall, as soon as possible, after receipt of notice of a fire, have an agent or representative at the fire, whose duty shall be to cut, deaden and test any of the power wires that might endanger the lives or property of anyone in that vicinity. The Town Electrical Inspector shall, upon receipt of notice of a fire, proceed at once to the scene of such fire and render such aid or

advice as may be required.

- E. INSPECT OLD WORK UPON REQUEST. Upon request of the property owner, the Town Electrical Inspector shall inspect any old wiring or electrical apparatus in or on any building or property within the corporate limits of the Town of Mills, County of Natrona. upon payment of a fee of Two Dollars (\$2.00) for residences, Five Dollars (\$5.00) for buildings other than residences, and shall thereupon issue a Certificate of Inspection if the installation is in accordance with the provisions of this Ordinance and the National Electric Code. In case the installation does not comply with the Ordinance and the National Electric Code, he shall issue a written statemen: as to the changes necessary to bring the installation up to the standard.
- F. NOTICE FROM INSPECTOR TO CONNECT OR DISCONNECT CIRCUIT. It shall be unlawful for any light, heat or power company to make any electrical connections to any building or property until a Certificate of Approval has been issued by the Town Electrical Inspector, (excepting power houses and sub-stations of electric light, heat and power companies, operating under a franchise granted by the Town of Mills, and excepting equipment installed by companies operating under a Federal, State or Town franchise in the telephone, telegraph, railroad and radio transmitting industries). All such firms, corporations or individuals shall, upon written notice from the Town Electrical Inspector, disconnect from any circuit as designated by said notice and shall not reconnect said circuit except upon written notice from the Town Electrical Inspector.

The Electrical Inspector is also hereby authorized and shall have the authority to cause the turning off of all electrical current and cut or disconnect, in cases of emergency, any wire where such electrical currents are dangerous to life or property or may interfere with the work of the Fire Department.

G. NOTICE GIVEN ON COMPLETION OF INSPECTION OTHER THAN FINAL INSPECTION.

After inspecting the electrical wiring of any building, the Town Electrical

Inspector shall leave notice in the form of a tag attached to the service switch.

This notice shall clearly state that the work has been passed upon by the

Electrical Inspector, and on new or remodeled construction, no workman shall lath

seal or in any manner conceal any electric wiring until he knows positively that

it has been passed. If the wiring is in such position as to interfere with the

completion of the building as called for by the plans, the wiring contracor must

be notified within twenty-four (24) hours to have the necessary changes made.

The Town Electrical Inspector must in all cases when such is practical, inspect

all electrical wiring within the corporate limits of the Town of Mills within

forty-eight (48) hours of the receipt of notice from the electrical contractor,

stating that the work is completed.

H. GENERAL SAFETY SUPERVISION. That the Town Electrical Inspector is hereby authorized, empowered and directed to have the general supervision over the placing, stringing and attaching of telephone, telegraph, electric light or other wires, only insofar as fire prevention, accident or injury to persons or property is concerned, and any or all of such wires or electrical apparatus now existing as well as those hereafter constructed and placed, shall be subject to such supervision.

SECTION 5. FINAL INSPECTION. A certificate of Inspection shall be issued by the Electrical Inspector when all electrical work covered by a permit is completed to the satisfaction of the Town Electrical Inspector, and it is hereby provided but not limited, that all plumbing and steam fittings, furnace work, gas fittings, and telephone wiring which is to be installed or to be made a part of the construction, must be in place before a Certificate is granted.

SECTION 6. REQUIREMENTS FOR PLANS AND SPECIFICATIONS. Any person, firm, corporation, partnership, architect or builder is required when drawing plans and specifications, to state in such plans and specifications, the location of all outlets, maximum watts at each outlet, and the circuiting of all outlets. The location of the main distribution panel and service attachment point shall be approved by the Town Electrical Inspector and the power company. All electrical work shown on plans and incorporated in the specifications shall conform to the Town Electrical Ordinance and the current issue of the National Electric Code. Architects and builders shall be required to furnish plans and specifications of proposed work as may be deemed necessary, together with the bid date, prior to the time of calling for bids. Such plans and specifications shall be approved by the Town Electrical Inspector before a permit is issued. All revision or change orders shall be also filed with the Electrical Inspector.

SECTION 7. FEES.

A. Written Application and Schedule of Fees. That before any company, firm, co-partnership, corporation or individual shall do any electric wiring, either new work or an addition to old work, a written application must be filed with the Town Electrical Inspector for a permit. The fee for such permit shall be paid at the time the permit is issued.

The installation of transformers shall be subject to inspection fees when such transformers are an integral part of the consumer's distribution system.

In order to insure prompt inspection, the full name and address of the owner and/or agent must be given at the time permit is secured.

Whenever possible, all permits must be secured and inspections called for before 1:30 p.m. on week days, and whenever practical and possible, inspections will be completed on the same day they are called.

SECTION 8. EXAMINATIONS

- A. The Town Electrical Inspector, upon application to him for a Master Electrician's License, shall forthwith notify the Electrical Board of Examiners. The applicant shall present satisfactory evidence of training and experience to qualify for examination. The qualifications are as follows:
 - (1) The applicant must have not less than four (4) year's experience as a journeyman electrician, or four (4) years in the electrical contracting business.
 - (2) Said applicant for examination must pass a Master's examination as to his knowledge of the rules and regulations for the installation of electrical wiring and equipment as set forth in the Ordinance of the Town of Mills and the current National Electric Code.

The Master's examination shall be practical in character and sufficiently strict to test the applicant's general qualifications and fitness for executing such work. The Board shall notify the Town Clerk in writing of the result of the

examination, and no license shall be issued unless and until the applicant shall pass such examination with a grade of eight-five (85%) percent or more.

- B. The Town Electrical INspector, upon application to him for a new Journeyman Electrician's License, shall forthwith notify the Electrical Board of Examiners. The applicant shall present satisfactory evidence of training and experience to qualify for examination. Qualifications are as follows:
 - (1) Applicant shall have at least four (4) year's experience in the electrical trade or have completed equivalent trade school training or bona fide apprenticeship training program. An indentured applicant in a bona fide apprenticeship training program with three (3) or more years experience or presently enrolled in a bona fide trade school may, at the discretion of the Board of Electrical Examiners, be given the examination for Journeyman Electrician's License.
 - (2) Said applicant for examination must pass a Journeyman"s examination as to his knowledge of the rules and regulations for the installation of electrical wiring and equipment as set forth in the Ordinance of the Town of Mills, and the National Electric Code.

The Journeyman's examination shall be practical in character and sufficiently strict to test the applicant's general qualifications and fitness for executing such work. The Board shall notify the Town Clerk is writing of the result of the examination, and no license shall be issued unless and until the applicant shall pass such an examination with a grade of seventy-five (75%) percent or more.

SECTION 9. EXAMINATION FEES.

A. Initial Examination Fees. Every person taking examination for a Master Electrician's License shall first pay to the Town of Mills an initial examination fee of Twenty-five Dollars (\$25.00), and every person taking an initial examination for a Journeyman Electrician's License shall first pay a fee of Twenty Dollars (\$20.00).

Fifteen Dollars (\$15.00) of the above fees, either for Master Electrician's License or Journeyman Electrician's License shall be paid to the Board of Examiners.

B. Reexamination. Upon failure to pass a Master or Journeyman Electrician examination, an applicant may appear for reexamination after the expiration of one month and upon the payment of the fees herein set forth.

SECTION 10. LICENSIS, BONDS, AND FEES.

A. Contractor's License and Fee. A Contractor's License shall grant the holder thereof the right and privilege to contract for the installation of any electrical wiring within the Town of Mills.

A Contractor's License shall be granted upon payment of Fifty Dollars (\$50.00) and presentation of evidence that at least one full-time employee is the holder of a valid Master Electrician's License. In the event a shop is without an employee holding a Master's License, they are hereby granted sixty (60) day's time to secure an employee with a Master's License. The annual

renewal fee for a Contractor's License shall be Twenty-five Dollars (\$25.00). B. Contractor's Bonds. Before any company, firm, copartnership, corporation or individual shall do any electric wiring, either new work or an addition to old work within the Town of Mills, a \$1,000.00 Corporate bond must be filed in the Office of Town Clerk. In order to guarantee payment of fees for permits issued, the Contractor must file a Five-Hundred Dollar (\$500.00) Surety Bond with the Town Clerk or pay the required fee when permit is issued. C. Master Electrician's License and Fee. A Master Electrician's License shall grant the holder thereof the right and privilege to do any electrical wiring that may be required of a Journeyman Electrician within the corporate limits of the Town of Mills and shall be a valid qualification for obtaining a Contractor's License upon proper application and payment of fee. Initial fee for a Master Electrician's License shall be Ten Dollars (\$10.00). A certificate card shall be issued to the applicant upon passing such examination. The annual renewal fee for such license shall be Five Dollars (\$5.00). The fee required for such license shall be paid to the Town of Mills. D. Any Master Electrician or Journeyman Electrician that has a license for the City of Casper, Wyoming, County of Natrona, need not acquire a license to work in the Town of Mills. E. Journeyman Electrician's License and Fee. That there shall be an electrical license known as a Journeyman Electrician's License which shall grant the holder thereof the right and privilege to do any electrical wiring that may be required of a journeyman wireman within the corporate limits of the Town of Mills and the annual fee for such license shall be Five Dollars (\$5.00). A certificate card shall be issued to the applicant upon his passing such examination. No Journeyman shall do any electrical wiring as provided for in this Ordinance without first securing a license to do so. F. License Required A valid Master or Journeyman Electrician's License shall be required of any and all persons performing any electric wiring as defined in this Ordinance, within the Town of Mills, except as provided for in Sections /2 and /3. G. Apprentice Electrician. Any licensed electrical contractor may employ apprentice electricians to assist Master or Journeyman Electricians. Such apprentice shall not be required to pass any examination, but shall be registered with the Electrical Inspector and shall work in the presence of and under the immediate supervision of a Master or Journeyman Electrician. H. Effective Date. That all licenses provided for in this Ordinance -8shall be granted for a period of one calendar year or fractional part thereof from January 1st to December 31st of each year. The renewal license fee for licenses not renewed on or before January 1st shall be one and one-half times the regular license fee.

SECTION 11. REVOCATION OF LICENSE.

A. Revocation. The Town Council of the Town of Mills, may revoke any electrical license upon the request of and proof by the Town Electrical Inspector of a refusal to comply with this Ordinance by any firm, corporation or individual holding either a contractor, Master or Journeyman Electrician's License.

Any person, firm or corporation whose license has been revoked in accordance with the provisions of this Section, may apply for a new license at the end of six (6) months from the date of revocation of such previous license. Any application for a new license so filed by any such person, firm, or corporation shall be referred to the Town Council for approval.

- B. Failure to Renew. Any license not renewed within thirty days of expiration shall be automatically declared invalid without privilege of renewal.

 SECTION 12. PRIVATE WORK.
- (A) A permit to perform electrical work in or about his own property may be issued to the owner, provided it is not a public place or place of business or worship, and that all work thereunder shall be done with his own hands. The Electrical Inspector, however, shall not issue such permit unless the person who is to perform the work is specifically named in the permit or countersigns the permit.
- (B) Under this Ordinance, a Permit would not be required to do normal maintenance work required on any building, structure or residence. However, any additions, extensions to, or modifications of existing electrical installations shall require an electrical permit.

SECTION 13. TEMPORARY LICENSE. A temporary Journeyman License for a

Thirty day period shall be granted upon payment of Twenty Dollars (\$20.00)

and a written application for Journeyman Electrician's License. The \$20.00

shall be applied to examination fee. Failure to pass examination or to take

examination (without valid reason at discretion of Board) shall result in forfeiture

of \$20.00 fee. Temporary permits may be renewed at discretion of Electrical Board.

SECTION 14. COMPLIANCE WITH NATIONAL ELECTRIC CODE. All wiring of twelve (12) volts or over within the corporate limits of the Town of Mills, shall be, at all times, installed in accordance with the current minimum requirements of the National Electric Code as compiled by the National Board of Fire Underwriters. In the interest of safety and sound construction practice, the following

requirements are also to be adhered to: (1) The electric wiring in all commercial or industrial types of buildings, in all multiple family dwellings, in buildings or any part of buildings whose usage is changed from residential to any other use, within the corporate limits of the Town of Mills, all wiring shall be in metal raceways. Metal raceways shall be defined as rigid (thick wall conduit) electric metallic tubing (thin wall conduit), metal moulding, flexible metallic conduit (but not BX), metal troughing and metal ducts. Where fibre duct or equivalent raceways may be installed underground in accordance with the National Electric Code they may be substituted in place of any of the above named types of raceways. In no case, within the corporate limits of the Town of Mills shall flexible armoured cable (BX) be installed. (2) All wiring on the external part of any building and all service entrances within the corporate limits of the Town of Mills shall be installed in conduit (rigid conduit, or electric metallic tubing). (3) All service entrance wires hereafter installed from the public utilities' service drop conductors, into the building or structure to be served, shall be in approved metal conduit (rigid conduit or electric metallic tubing) equipped at the outer end with a service head fitting. Service conduit, and the meter enclosure and service cabinet shall be securely bonded and grounded, but in no case shall the conduit system be used as the secondary ground. The minimum wire size that may be used for any service entrance hereafter installed shall be a 2 Number 2 AWG and 1 Number 4 AWG. The minimum conduit size that may be used for any service entrance hereafter installed shall be one and one-fourth (12") inches. The minimum number of conductors to be used in service cabinet to be installed with service equipment hereafter installed shall be sixteen (16) circuit-100 ampere panel. Main disconnect breakers or switches shall be properly identified. (4) All Service Entrances to Mobile Homes shall have one inch (1") conduit with a service entrance cap and number six (6) type THW wire. There shall be a sixty amp (60) disconnect switch as part of the service entrance equipment. (5) Equipment and service grounds are to be rigidly inspected and tested by the Town Electrical Inspector and no inspection tag is to be attached to any installation which is not adequately grounded in accordance with the grounding requirements as contained in the current edition of the National Electric Code. (6) Service ground shall be a minimum of No. 6 A.W.G. and connected on the street side of water meter. -10originally wired in metal raceways, flexible metallic conduit (Green Field) of the type allowing the pulling and withdrawing of wires when conduit is in place, may be used prividing existing circuits are adequate. Where extensions are made to residential jobs which are originally wired in knob and tube, non-metallic sheathed cable may be used for extension providing existing circuits are adequate, or is of a commercial nature, where metal raceways are required.

(8) No wires smaller than (#12) AWG shall be used in wiring of 110 volts or over within the corporate limits of the Town of Mills except for remote control circuits.

SECTION 15. QUESTIONS NOT PROVIDED FOR IN THIS ORDINANCE. That all questions not provided for in this ordinance or covered by the National Electric Code, pertaining to the installation of electrical wires and apparatus and any questions that may arise concerning the interpretation of this Ordinance shall be decided by the Town Council.

SECTION 16. BOARD OF APPEALS. The Board of Appeals shall consist of the Mayor and Town Council of the Town of Mills.

Any person, firm, company, corporation or partnership may appeal a decision of the Town Electrical Inspector by giving written notice of such appeal to the Town Clerk within a period of five (5) days of the Electrical Inspector's decision. The Electrical Inspector shall present, in writing, to the Board within the five (5) day period, all facts pertaining to the decision rendered by him.

The Town Council shall have five (5) days in which to study the appeal and will then submit, in writing, their decision.

SECTION 17. NATIONAL ELECTRIC CODE. That the National Electric Code' is hereby adopted in its entirety and a copy thereof is on file in the Office of the Town Clerk for examination.

SECTION 18. BUILDING INSPECTOR AUTHORIZED TO ACT AS ELECTRICAL INSPECTOR.

That during the absence of the Electrical Inspector of the Town of Mills, or in any case of incapacity of such officer to perform his duties as provided by Ordinance, or in the event that no such officer has been duly appointed and qualified, it shall be the duty of the Building Inspector of the said Town, and the said Building Inspector is hereby authorized and directed to perform the duties of the aforesaid Electrical Inspector, and the said Acting Electrical Inspector shall have and possess all of the official powers of the regular Electrical Inspector, as provided by this Ordinance and shall have full authority to act under

such power.

SECTION 19. REPEALED. Ordinance Numbers 89 and 89-A and any and all Ordinances or parts of Ordinances in conflict herewith, are hereby repealed.

SECTION 20. SAVINGS CLAUSE. If any section, subsection, sentence, clause of this ordinance is, for any reason, held to be unconstitutional, such decision shall not affect the validity of the remaining portions of this ordinance.
