## ORDINANCE NO. 164

AN ORDINANCE PRESCRIBING THE PENALTY FOR VIOLATION OF ORDINANCES OF THE TOWN OF MILLS, NATRONA COUNTY, WYOMING, AND FOR FAILURE TO PAY FINE AND COSTS.

BE IT ORDAINED BY THE GOVERNING BODY OF THE TOWN OF MILLS, NATRONA COUNTY, WYOMING:

## Section 1. <u>VIOLATIONS--PENALTY</u>.

Any person violating any of the provisions or failing to comply with any of the mandatory requirements of the ordinances of the Town of Mills shall be guilty of a misdemeanor. Any person convicted of a misdemeanor under the ordinances of the Town of Mills shall be punished by a fine of not more than one hundred dollars, or by imprisonment not to exceed three months. Each such person shall be guilty of a separate offense for each and every day during any portion of which any violation of any provision of the ordinances of the Town of Mills is committed, continued, or permitted by any such person, and he shall be punished accordingly.

## Section 2. FAILURE TO PAY FINE, COSTS.

Upon the rendition of judgment against any defendant for violation of any ordinance of this Town, the police magistrate or justice of the peace shall make an order and enter the same upon his docket, that if the neglect or refuse to satisfy such judgment and costs of suit, he shall be confined in the town jail or other place of confinement provided for that purpose, one day for each one dollar and fifty cents of such judgment and costs, and during such confinement he may be required to labor upon the streets or do other work for the Town under the supervision and direction of the Mayor. Execution shall be issued immediately upon the rendition of judgment.
