ORDINANCE NO. 171

A BILL for an ordinance to amend and re-enact Ordinance 130,
Section 18C, 1962, as amended by Ordinance 159, Section 1, 1966,
regulating the speed of vehicular traffic within the Town of Mills,
Wyoming.

BE IT ORDAINED BY THE GOVERNING BODY OF THE TOWN OF MILLS, NATRONA COUNTY, WYOMING:

Section 1 - Speed Zones - Speed Limits. In zones where special hazards exist, the Town Marshall shall have authority to place "danger" and "go slow" signs to clearly mark said zones.

The maximum lawful speed of any motor vehicle shall be as follows:

- (1) Fifteen (15) miles per hour in all alleys.
- (2) Twenty (20) miles per hour on all streets other than streets designated by ordinance as through streets.
- (3) Thirty (30) miles per hour on through streets with the following exceptions:
 - (a) All of Fourth Street on which the speed limit shall be twenty (20) miles per hour.
 - (b) That portion of Wyoming Boulevard between the intersection of Ninth Street and Wyoming Boulevard and U. S. Highway 20-26, on which the speed limit shall be twenty (20) miles per hour.
