ORDINANCE No. 174

AN ORDINANCE Providing for the compensation of the Mayor, Councilmen and employees of the Town of Mills, Wyoming, and repealing Ordinances Numbered 88, 88-A, 88-B, 88-C, 88-D, 88-E, 88-F and 165.

BE IT ORDAINED BY THE GOVERNING BODY OF THE TOWN OF MILLS, WYOMING:

Section 1. COMPENSATION OF MAYOR.

The Mayor of the Town of Mills shall be paid the sum of \$8.00 for each regular or special council meeting actually attended by him.

Section 2. COMPENSATION OF COUNCILMEN.

The salary for each councilman of the Town of Mills shall be \$4.00 for actual attendance at each regular or special meeting.

- Section 3. COMPENSATION OF EMPLOYEES, INCLUDING,
 BUT NOT LIMITED TO, THE CLERK-TREASURER,
 TOWN MARSHAL, POLICE JUDGE, WATER-STREETSEWER COMMISSIONER, FIRE CHIEF, BUILDING
 INSPECTOR, ELECTRICAL INSPECTOR, AND TOWN
 ATTORNEY.
- A. Employees of the Town of Mills shall be paid salaries commensurate with the Town's ability to pay and in proportion to the value of the services rendered and the duties performed.
- B. The Town Council shall, at the first meeting after the start of the Town[†]s fiscal year, or as soon thereafter as possible, by resolution set the salaries of the employees of the Town which will become effective on the first day of the next succeeding month. The Town Council may, during the fiscal year, review the salaries paid to the Town employees and by resolution make such adjustments, upwards or downwards as the Council deems necessary. Provided, however, that before reducing the salary of any employee the employee affected shall be notified of the proposed action and given an opportunity to appear before the Council.

Section 4. Repealing Ordinances.

That Ordinances Numbered 88, 88-A, 88-B, 88-C, 88-D, 88-E, 88-F and 165, be and the same are hereby repealed.
