AN ORDINANCE TO ANNEX TO THE TOWN OF MILLS, A PARCEL OF LAND LOCATED IN AND BEING A PART OF THE NORTH HALF OF THE NORTHWEST QUARTER (N½NW¼) OF SECTION SEVEN (7), TOWNSHIP 33 NORTH, RANGE 79 WEST OF THE 6th P.M., NATRONA COUNTY, WYOMING.

BE IT ORDAINED BY THE GOVERNING BODY OF THE TOWN OF MILLS, WYOMING.

SECTION ONE: That the following described unplatted lands contiguous with and adjacent to the Town of Mills, Natrona County, Wyoming are hereby annexed, added to, taken into and made a part of the said Town of Mills:

A parcel located in and being a part of the North half of the northwest quarter (N½NW¼) of Section Seven (7), Township 33 North, Range 79 West of the Sixth Principal Meridian, Natrona County, Wyoming, and being more particularly described as follows:

Beginning at the southwesterly corner of said parcel, said point being located in the southerly line of said N½NW¼ of Section 7 at north 89°20' east 453.0 feet from the southwesterly corner thereof; thence from said point of beginning north 0°48' east 204.20 feet to a point; thence south 89°20' west 170.0 feet to a point in the easterly line of Sinclair Oil and Gas Addition to the Town of Mills, Wyoming; thence north 0°48' east 205.43 feet to Corner 3 of said Addition; thence north 89°24' east 140.0 feet to Corner 4 of said Addition; thence north 0°48' east 358.15 feet to Corner 5 of said Addition and a point in the southerly right of way line of U.
