

ORDINANCE NO. 184

AN ORDINANCE PROHIBITING THE INSTALLATION OR MAINTENANCE OF ANY SIGN, FENCE, HEDGE, SHRUBBERY, TREE, NATURAL GROWTH OR OTHER OBSTRUCTION ON CORNERS OF INTERSECTIONS, AND PROVIDING EXCEPTIONS THERETO.

BE IT ORDAINED BY THE GOVERNING BODY OF THE TOWN OF MILLS, WYOMING.

SECTION 1. OBSTRUCTIONS PROHIBITED. On any corner lot of public or private property, such corner lot formed by intersecting streets, it shall be unlawful to install, set out or maintain, or to allow the installation, setting out or maintenance of any sign, fence, hedge, shrubbery, tree, natural growth, or other obstruction within that triangle formed by measuring along the property line a distance of 20 feet each direction from the corner post of the property nearest the intersection, with a line drawn to form a base.

SECTION 2: EXCEPTIONS. The foregoing provisions shall not apply to the following locations, structures, signs or natural growth:

(1) To permanent buildings or supporting members appurtenant thereto existing on the date this Ordinance becomes effective.

(2) To public utility poles.

(3) To hedges or other plants or natural growth trimmed or maintained at a height of thirty-six inches or less above the lowest grade of the street parallel to such hedge, plant or other natural growth.

(5) To ornamental or other fence:

(a) The height of which does not exceed 36 inches above the lowest grade of the street parallel to such fence, or

(b) The height of which exceeds 36 inches, but in which the ratio of the solid portion of the fence to the open portion does not exceed one to four.

(6) To trees which are no closer than six feet apart, and are at all times trimmed of sucker growth to a height of not less than eight feet above the lowest grade of the street parallel to such tree or trees.

(7) To signs mounted ten feet or more above the ground, the supports of which are not more than six inches in diameter and not less than four feet apart.

(8) To any obstruction located on property where the contour of the ground is such that there could be no cross visibility at the intersection in the absence of the obstruction.

SECTION 3: SCOPE. No obstruction as herein defined shall be excepted from the application of this chapter because of its being in existence at the time of the adoption herein, unless expressly exempted herein.

SECTION 4: SAVINGS CLAUSE. If any section, sub-section, sentence or clause of this Ordinance is, for any reason, held to be unconstitutional, such decision shall not affect the validity of the remaining portions of this Ordinance.
