

ORDINANCE NUMBER TWENTY-FOUR.

AN ORDINANCE granting to Natrona Power Company, its successors and assigns, the authority, right, privilege and franchise to generate, transmit and distribute electricity and electrical currents for the purpose of furnishing the same for light, heat, power and all other purposes to the Town of Mills in Natrona County in the State of Wyoming, and to the inhabitants thereof, and all other persons and corporations desirous of using the same along, in, across, over, upon and under the streets, alley-ways, avenues, lanes, bridges and public places in said Town of Mills as the same now exists or may hereafter be acquired, laid out or extended, and in addition thereto the authority, right, privilege and franchise to locate, construct, operate and maintain works, poles, wires, subways, conduits, underground conduits, electrical conductors, cross braces, cross arms, feeders and all other necessary or proper appurtenances and appliances for the reception into said Town of Mills and the generation, transmission, and distribution in and through the same of said electricity and electrical currents for the purposes aforesaid along, in, across, over, upon, and under the said streets, alley-ways, avenues, lanes, bridges and public places of said Town of Mills as the same now exist or may hereafter be acquired, laid out or extended.

BE IT ORDAINED by the Town Council of the Town of Mills in Natrona County in the State of Wyoming;

Sec.1. There is hereby granted to Natrona Power Company, a Delaware corporation, duly qualified and doing business in the State of Wyoming, and its successors and assigns, a full and complete authority, right, privilege and franchise to generate, transmit, and distribute electricity and electrical currents for the purpose of furnishing the same for light, heat and power and all other purposes to the Town of Mills in Natrona County, in the State of Wyoming, and to the inhabitants thereof and all other persons and corporations desirous of using the same along, in, across, over, upon and under the streets, alley-ways, avenues, lanes, bridges and public places in said Town of Mills as the same now exist or may hereafter be acquired, laid out or extended, and in addition thereto the authority, right, franchise and privilege to locate, construct, operate and maintain works, poles, wires, subways, conduits, underground conduits, electrical conductors, cross braces, cross arms, feeders and all other necessary or proper appurtenances and appliances for the reception into said Town of Mills and the Generation, transmission and distribution in and the through the same of said electricity and electrical currents for the purposes aforesaid, along, in, across, over

upon, and under the said streets, alley-ways, avenues, lanes, bridges and public places in said Town of Mills as the same now exist or may hereafter be acquired, laid out or extended.

Sec.2. All pole lines and works hereby authorized to be erected shall be located in such a manner as will not necessarily interfere with the ordinary and customary use of said streets and alleys.

Sec.3. All rights and privileges granted under this franchise to the said Natrona Power Company and its successors and assigns, shall be in full force and effect for the term of fifty years from and after the date this ordinance becomes effective.

Sec.4. Unless the said Natrona Power Company or its successors or assigns, shall within thirty days from the passage of this ordinance file an unconditional acceptance thereof in writing with the Town Clerk of said Town of Mills.

Sec.5. This ordinance shall take effect and be in full force upon the posting thereof in the manner required by law.
