## ORDINANCE NO. 281

AN ORDINANCE TO REPLAT LOTS 18, 19, 20 & 21 IN BLOCK 6 OF THE TOPAZ ADDITION NUMBER ONE, TOWN OF MILLS, NATRONA COUNTY, WYOMING.

WHEREAS, the Town of Mills has annexed the lands hereinafter described as a portion of the Topaz Addition Number One, Town of Mills, Natrona County, Wyoming; and,

WHEREAS, the Owner desires to replat said property hereinafter described so as to divide said property into separate lots for installation of town house units as described on the plat filed simultaneously herewith; and,

WHEREAS, said replatting and installation of town house units is consistent with the general development of the area encompassing said property:

NOW, THEREFORE, BE IT ORDAINED by the Town Council of the Town of Mills, Wyoming:

SECTION 1. That a certain tract of land lying within the boundaries of the Topaz Addition Number One, Town of Mills, Natrona County, Wyoming, more particularly described as follows:

Lots 18, 19, 20 and 21, Topaz Addition Number One, Town of Mills, Natrona County, Wyoming,

be and the same is hereby replatted to comprise the following units, to-wit:

Tracts A through P inclusive; Block 1, Lots 1 through 24, inclusive; Block 2, Lots 1 through 25, inclusive; Block 3, Lots 1 through 14, inclusive; Block 4, Lots 1 through 14, inclusive;

SECTION 2. That a plat showing the boundaries of said annexed tract has been submitted to and is approved by the Town Council of the Town of Mills and the Mayor and Town Clerk are authorized to sign, attest and affix the seal of the Town on said plat, and said plat shall be filed for record in the Office of the County Clerk and Ex-Officio Register of Deeds of Natrona County, Wyoming.
