## ORDINANCE NO. 292

AN ORDINANCE ANNEXING PACIFIC ADDITION TO THE TOWN OF MILLS, NATRONA COUNTY, WYOMING.

WHEREAS, the Town of Mills is desirous of annexing the lands hereinafter described and including said lands within the corporate limits of the Town of Mills; and,

WHEREAS, it has been determined by the Town Council of the Town of Mills that an annexation of the area hereinafter described is for the protection of the health, safety, and welfare of the persons residing in the area and in the Town of Mills; and,

WHEREAS, it has been determined that the development of the area sought to be annexed would constitute a natural, geographical, economical and social part of the Town of Mills; and,

WHEREAS, it has been determined by the Town Council of the Town of Mills that the area sought to be annexed is a logical and feasible addition to the Town of Mills and that the extension of basic services such as water and sewer systems, police and fire protection and other services customarily available to residents of the Town of Mills can reasonably be furnished to the area proposed to be annexed; and,

WHEREAS, it has been determined by the Town Council that the area sought to be annexed is contiguous with the adjacent to the boundaries of the Town of Mills; and,

WHEREAS, it has been determined that the petitioner is the sole owner of all the property sought to be annexed and therefore, no public hearing is required prior to the annexing said land;

NOW THEREFORE, BE IT ORDAINED by the Town Council of the Town of Mills, Wyoming:

North, Range 79 West of the Sixth Principal Meridian, Natrona County, Wyoming, described on Exhibit "A" attached hereto and by this reference made a part hereof be, and the same is annexed to and included within the boundaries of the Town of Mills, Natrona County, Wyoming.

SECTION 2. That the area herein annexed and herein described shall be known as Pacific Addition to the Town of Mills, Natrona County, Wyoming.

SECTION 3. That a plat showing the boundaries of said annexed tract has been submitted to and is approved by the Town Council of the Town of Mills and the mayor and town clerk are authorized to sign, attest and affix the seal of the town on said plat, and said plat shall be filed for record in the office of the County Clerk and Ex-Officio Register of Deeds of Natrona County, Wyoming.

SECTION 4. That the annexation of said tract of land to the Town of Mills shall become effective upon passage of this ordinance.

## PACIFIC ADDITION METES AND BOUNDS DESCRIPTION

Pacific Addition is a portion of Lot 7, (SW4 SW4),
Section 6, Township 33 North, Range 79 West of the Sixth
