ORDINANCE NO. 294

AN ORDINANCE ANNEXING AGATE ADDITION TO THE TOWN OF MILLS NATRONA COUNTY, WYOMING

WHEREAS, the Town of Mills is desirous of annexing the the lands described in Exhibit A attached hereto and including said lands within the Corporate Limits of the Town of Mills; and

WHEREAS, it has been determined by the Town Council of the Town of Mills that an annexation of the area hereinafter described is for the protection of the health, safety and welfare of the persons residing in the area and in the Town of Mills; and

WHEREAS, it has been determined that the development of the area sought to be annexed would constitute a natural, geographical, economical and social part of the Town of Mills; and

WHEREAS, that it has been determined by the Town Council that the area sought to be annexed is a logical and feasible addition to the Town of Mills and that the extention of basic services such as water and sewer systems police and fire protection and other services customarily available to residents of the Town of Mills can reasonably be furnished to the area proposed to be annexed; and

WHEREAS, it has been determined by the Town Council that the area sought to be annexed is contiguous with and adjacent to the boundaries of the Town of Mills; and

WHEREAS, it has been determined that the petitioners for annexation are the owners of all the land sought to be annexed, and that therefore no public hearing is required prior to annexing said land and

WHEREAS, a annexation and subdivision agreement must be prepared and agreed to between the parties

NOW THEREFORE BE IT ORDAINED by the Town Council of the Town of Mills, Wyoming

That a certain tract of land being all of the Agate Addition to the Town of Mills, described in Exhibit A attached hereto be and the same is annexed to and included within the boundaries of the Town of Mills, Natrona County, Wyoming.

SECTION 2. That the area herein annexed and herein before described shall be known as Agate Addition to the Town of Mills, Natrona County, Wyoming.

SECTION 3. That a Plat showing the boundaries of said annexed tract has been submitted to and is approved by the Town Council of the Town of Mills and the Mayor and Town Clerk are authorized to sign, attest and affix the seal of the Town on said Plat, said Plat shall be filed for record in the Office of the County Clerk and Ex-Officio Register of Deeds of Natrona County, Wyoming.

SECTION 4. That the annexation of said tract of land to the Town of Mills shall become effective upon the happening of two (2) events;

- 1. the passage of this ordinance and
- execution by the Town of Mills and the petitioners of an annexation and subdivision agreement.
