ORDINANCE NO. 297

AN ORDINANCE TO AMEND AND REPEAL AND TO RE-ENACT ORDINANCE NO. 130, SECTION 14 (1962), APPEARING IN MILLS MUNICIPAL CODE AS 10.20.040 TO REMOVE THE WORD ONLY FROM THE ORDINANCE.

BE IT ORDAINED BY THE GOVERNING BODY OF THE TOWN OF MILLS, WYOMING.

## SECTION 1.

Ordinance 130, § 14 (1962), appearing in Mills Municipal Code as 10.20.040 presently reads "Duty upon striking fixtures upon a street - the driver of any vehicle involved in an accident resulting only in damage to fixtures or other property legally upon or adjacent to a street, shall take reasonable steps to locate and notify the owner or persons in charge of the property, of the fact and of his name, address and of the registration number of the vehicle he was driving and shall upon request and if available exhibit his operators or chauffeurs license."

It is hereby amended to read, "Duty upon striking fixtures upon a street - the driver of any vehicle involved in an accident resulting in damage to fixtures or other property legally upon or adjacent to a street, shall take reasonable steps to locate and notify the person or persons in charge of the property, of the fact, and of his name and address and ofthe registration number of the vehicle he is driving and shall upon request and if available exhibit his operators or chauffeurs license."
