AN ORDINANCE TO ADOPT GENERAL SPECIFICATIONS FOR PORTLAND CEMENT CONCRETE, CONCRETE CURB, CURBWALK AND VALLEY GUTTERS, EXCAVATION FOR PAVEMENT, PAVEMENT SUB BASE COURSE, PAVEMENT BASE COURSE, BITUMINOUS PRIME COAT, BITUMINOUS TACK COAT, ASPHALTIC CONCRETE BINDER AND WEARING COURSE AND STORM SEWERS FOR ALL TOWN IMPROVEMENTS.

WHEREAS, general specifications are needed to provide for the uniform construction of improvements within the Town.

NOW BE IT ORDAINED, BY THE GOVERNING BODY of the Town of Mills, Natrona County, Wyoming, as follows:

SECTION 1. The general specifications for the Town of Mills, Mills, Wyoming is adopted as a specifications to be used in making any public improvements or improvements later to be dedicated to the public within the Town of Mills.

Any future amendments to the specifications shall contain the year of the Ordinance and the revised title.
