ORDINANCE NO. 319

AN ORDINANCE TO AMEND AND RE-ENACT PART OF ORDINANCE 274, SECTION 2, 1979, APPEARING IN THE MILLS MUNICIPAL CODE AS § 17.08.030, SUBPARAGRAPH H, SO AS TO INCLUDE AN ANNEXATION FEE TO BE PAID.

WHEREAS, Town Council of the Town of Mills has determined that a fee should be charged for annexations to the Town of Mills to cover the costs of additional workload upon the Clerk and her assistants, the additional costs of engineering review and additional costs of attorneys fees.

BE IT ORDAINED by the governing body of the Town of Mills, Natrona County, Wyoming, that Ordinance #274, Section 2, a part thereof, 1979, appearing in the Mills Municipal Code as 17.08.030 (h), which presently reads:

"A subdivision fee of \$10.00 per lot, with a \$100.00 minimum and \$1000.00 maximum, plus a \$50.00 fee required by the County Clerk for recording the final plat.

Example: 12 lots equal \$120.00, plus \$50.00, equals \$170.00, total fee;"

is hereby amended to read as follows:

"A subdivision and/or annexation fee of \$10.00 per lot, with a \$100.00 minimum and \$1000.00 maximum, plus a \$50.00 fee required by the County Clerk for recording the final plat.

Example: 12 lots equal \$120.00, plus \$50.00, equals \$170.00, total fee;"
