WHEREAS, the Town Council has determined that there is a need to update the traffic control Ordinances of the Town of Mills; and,

WHEREAS, the Town Council has further determined that to adopt the Uniform Act regulating traffic on highways, as specified by State Statute will help to establish uniformity amongst the laws of the municipalities in the Mills area.

BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF MILLS, WYOMING, as follows:

SECTION 1:

Those portions of the Ordinances hereinafter listed are hereby specifically repealed: Ordinance 130 §§ 1, 3 through 15, 21 through 44, 46, 50 through 59, 61 through 68 and 72 (Part) (1962) appearing as §§ 10.04.010 through 10.04.360, 10.08.010 through 10.08.040, 10.16.010 through 10.16.040, 10.20.010 through 10.20.040, 10.24.010, 10.32.010 through 10.32.230, 10.36.010, 10.40.010 through 10.40.080, 10.44.010 through 10.44.020, 10.44.040 through 10.44.110, 10.52.010

All other Ordinances of the Town of Mills, including traffic related Ordinances, not hereby specifically repealed, are still in full force and effect.

SECTION 2:

The following State Statutes, being a portion of the Uniform Act regulating traffic on highways, are hereby adopted by reference as if they had been fully stated in this Ordinance: W.S. §§ 31-5-101 through 31-5-104, 31-5-106 through 31-5-110, 31-5-112, 31-5-115 through 31-5-119, 31-5-121 through 31-5-124, 31-5-226, 21-5-228 through 31-5-232, 31-5-301, 31-5-303 through 31-5-307, 31-5-402 through 31-5-407, 31-5-503, 31-5-505 through 31-5-960, 31-5-1101(a), 31-5-1102 through 31-5-1108, 31-5-1112, 31-5-1202 through 31-5-1214.
