ORDINANCE NO. 329

AN ORDINANCE AMENDING ORDINANCE 301, THE 1981-82 BUDGET, TO MODIFY THE BUDGET, TO TRANSFER FUNDS FROM A DEPARTMENT TO ANOTHER AND TO APPLY FUNDS NOT CONTEMPLATED IN THE ORIGINAL 1981-82 BUDGET TO THE APPROPRIATE DEPARTMENTS.

WHEREAS, the Town Council of the Town of Mills has determined that there are funds existing in departments that are not being used and are not likely to be used before the end of the year; and,

WHEREAS, there are other departments within the Town government that are short of funds and will be needing funds before the end of the year. It has been determined that the budget should be modified and funds should be transferred from one department to the other to more adequately use the funding available to the Town; and,

WHEREAS, there are funds available to the Town through the severance tax which were not contemplated at the time of the original 1981-82 budget and should be transferred to the appropriate departments.

BE IT ORDAINED BY THE GOVERNING BODY OF THE TOWN OF MILLS, that Ordinance No. 301, attached hereto as Exhibit "A" should be amended to read as is contained in Exhibit "B", to reflect the transfer of funds from department to department and to pledge funds that have come into existence since the adoption of the 1981-82 budget to the appropriate departments.
