## ORDINANCE NO. 337

AN ORDINANCE TO VACATE A PORTION OF 6TH STREET IN THE TOWN OF MILLS.

WHEREAS the Town Council of the Town of Mills has determined that it would be in the best interest of the Town and to all parties involved that a portion of 6th Street in the Town of Mills, directly adjoining Lots 15 and 16, Block 49 of the original plat of the Town of Mills, Natrona County, Wyoming should be vacated; and,

WHEREAS, the Town of Mills has altered its course of street improvements so as to avoid the removal of the house located on the above mentioned lots; and,

WHEREAS, it has been determined that the Town of Mills and the general public has not been and has in the past not used that portion of the street right-of-way.

THEREFORE, be it ordained by the governing body of the Town of Mills as follows:

#### SECTION 1:

That that portion of 6th Street immediately adjoining lot 15 and 16, Block 49 of the Town of Mills, Natrona County, Wyoming, more particularly described in Exhibit "A", should be vacated.

### SECTION 2:

The Town Engineer is hereby instructed to prepare a re-plat of that portion of 6th Street affected by this vacation for filing in the office of the County Clerk.

#### SECTION 3:

That the Mayor is hereby authorized and directed to execute and the Town Clerk to attest a Quit Claim Deed to Donald P. Libolt and Lois Libolt, husband and wife, with a recitation that the portion of the street was vacated.
