## ORDINANCE NO. 36A

AN ORDINANCE GRANTING TO FARGO OIL CO., AWYOMING CORPORATION, OF CASPER, WYOMING, ITS SUCCESORS AND ASSIGNS, AFRANCHISE TO BUILD, LAY, CONSTRUCT, MAINTAIN AND OPPERATE A SIX INCH IRON OIL CARRYING PIPE LINE UPON, IN AND UNDER PENDELL BOULEVARD AND RAILWAY AVENUE, AND A TELEPHONE LINE FROM THE WEST END OF PENDELL BOULEVARD TO A POINT OPPOSITE THE ALLEY BETWEEN BENTON AVENUE AND RIVER VIEW AVENUE IN THE TOWN OF MILLS, NATRONA COUNTY?WYO.

BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF MILLS, NATRONA COUNTY, STATE OF WYOMING:-

Sec. 1, There is hereby granted to the Fargo Cil Co., a Wyo. corporation, of Casper, Wyo., its successors and assigns, a full and complete right, authority, Privelage and franchise, to lay, build, construct, opperate and maintain a six(6) inch extra heavy iron oil carrying pipeline and fittingsover, upon, in and under Pendell Boulavard And Northwestern Avenue, and a telephone from the west end of Pendell Boulavardto a point opposite the alley between Benten and Riverview Avenue, in the Town of Mills, Natrona County, Wyoming.

Sec. 2, Said oil carrying pipeline shall be laid along the North end of Pendell Boulavard not more than two \$2) feet from the North side of said Pendell Boulavard, and shall be laid along Northwestern Avenue from the property line to within eight (8) feet of the water maine on the easterly side of the said Northwestern avenue; said line shall be laid so as not to injure or interfere with the water lines and service lines of the Town of Mills, aforesaid and so as not to injure or inter fere with other water, gas oil or gasline lines laid in said Pendell Boulavard and Northwestern Avenue; said telephone line shall be built and constructed between the property line and pipeline on the north line of Pendell Boulavard in the Town of Mills aforesaid.

Sec. 3, All the rights and privilages granted to the Fargo Gil Co. under this franchise or its succesors and assigns, shall be in full forse and effect for a term of ninety-nine (99) years from and after this ordinance becomes effective.

Sec. 4, The Mayor and Clerk of the Town of Mills are Authorised and directed to enter into a contract with the Fargo Oil Co. embodying the terms of this franchise.
