ORDINANCE NO. 376

AN ORDINANCE REQUIRING COMPLIANCE WITH SANITARY SEWER DESIGN CRITERIA AND THE THE WATER MAIN DESIGN CRITERIA IN DESIGN OF ALL SANITARY SEWER AND WATER MAIN SYSTEMS WITHIN THE TOWN OF MILLS; AND REOUIRING COMPLIANCE WITH PARTICULAR SECTIONS WITHIN THE WYOMING PUBLIC WORKS SPECIFICATIONS WHICH APPLY TO STANDARD SEWER AND WATER MAIN SANITARY CONSTRUCTING CONSTRUCTION FOR SANITARY SEWER AND WATER MAIN SYSTEMS WITHIN THE TOWN OF MILLS: TO ENSURE TOWN COMPLIANCE WITH THE APPLICABLE STATE AND REGULATIONS REQUIRED BY THE FEDERAL 0F ENVIRONMENTAL WYOMING DEPARTMENT QUALITY, WATER QUALITY DIVISION.

NOW, THEREFORE, be it ordained by the Governing body that the Town of Mills, Wyoming adopts regulations by reference for design and construction of water and sewer systems for the Town of Mills as designated hereafter by Articles 1.1-1.3.9 with attachments. The purpose of this Ordinance is to assure compliance with the applicable State and Federal Regulations required by the Wyoming Department of Environmental Quality, Water Quality Division.
