ORDINANCE NO. 400

AN ORDINANCE AMENDING ORDINANCE 312, ZONING CODIFIED AS CHAPTER 18, TOWN OF MILLS CODE TO DEFINE RECYCLING CENTERS AND ESTABLISH RECYCLING CENTERS AS A PERMITTED USE IN INDUSTRIAL DISTRICTS.

BE IT ORDAINED BY THE GOVERNING BODY OF THE TOWN OF MILLS, WYOMING.

WHEREAS, recycling has become an important community service, and;

WHEREAS, the Town of Mills desires to encourage recycling centers and allow them in Mills and;

WHEREAS, the Town is not desirous of allowing junk yards within the town.

NOW THEREFORE, be it ordained by the Town Council of the Town of Mills,

Wyoming:

Section 18.04.030, Mills Zoning definitions, is hereby amend to include:

RECYCLING CENTER: A building and/or premises used for the recycling: purchase, and donation of metals, paper, and glass to be packaged and sold for recycling purposes; exclusive of automobile parts, bodies, batteries, petroleum products and all materials defined as hazardous by federal, state and local regulations as they pre-exist or are hereafter amended, and exclusive of any operation that salvages motor vehicles or other similar equipment.

and, <u>Section 18.08.030</u>, permitted uses, is hereby amended to include recycling centers, as defined above, as a special review use in the Established Industrial (E-I), and Developing Industrial (D-I) districts.
