

ORDINANCE NO. 402

AN ORDINANCE PROHIBITING OPERATION OF A MOTOR VEHICLE UNLESS PROPERLY REGISTERED AND INSURED AND PROHIBITING THE OPERATION OF A MOTOR VEHICLE WITHOUT A VALID DRIVER'S LICENSE; PROHIBITING DRIVING A MOTOR VEHICLE WHILE LICENSE IS SUSPENDED OR REVOKED; ESTABLISHING PENALTIES AND EXEMPTIONS.

BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF MILLS, WYOMING:

Section 1. Operator's License or Chauffeur's License Required. It is unlawful for any person to drive a motor vehicle upon the streets of this Town unless such person has in possession a valid operator's license issued or recognized by the State if such operator's license is required of such person under the laws of the State, or chauffeur's license if a chauffeur's license is required under the laws of the State.

Section 2. Driver's License Restrictions. It is unlawful for any person to:

(a) Display or permit to be displayed or have in his possession any canceled, revoked, suspended, fictitious, or fraudulently altered driver's license;

(b) Lend his or her driver's license to any other person or knowingly permit the use thereof by another;

(c) Display or represent as one's own any driver's license not issued to him or her;

(d) Fail or refuse to surrender to the Wyoming State Department of Revenue and Taxation upon lawful demand any driver's license which has been suspended, revoked, or canceled;

(e) Use a false or fictitious name in any application for a driver's license or knowingly make a false statement or knowingly conceal a material fact or otherwise commit a fraud in any application for a driver's license.

Section 3. Driving While License Suspended or Revoked Prohibited. It is unlawful for any person to operate a motor vehicle within the Town of Mills or within any area over which the Town has jurisdiction at a time when his or her privilege

to do so has been canceled, suspended, or revoked by the State of Wyoming or any other jurisdiction.

Section 4. State Registration and Licensing Required. It is unlawful for a person to own, operate, store, park, or otherwise maintain a motor vehicle upon the public streets, alleys, or highways of the Town without first having registered the vehicle, obtained a license therefor, and affixed thereto such license plates as are required, all in accordance with the applicable laws of the State of Wyoming pertaining to the licensing and registration of motor vehicles, as such laws now exist and as the same may from time to time be amended.

Section 5. Automobile Liability Policy or Equivalent Required--Penalty--Exemptions. It is unlawful for the owner or a driver of a motor vehicle that is required by the laws of the State of Wyoming to be licensed to knowingly operate or permit the operation of the vehicle by another within the Town of Mills or within any area over which the Town has jurisdiction without having in full force and effect an automobile liability policy as defined in §31-9-405 W.S., surety bonds as provided in §31-9-408 W.S., or cash and securities deposited as provided in §31-9-409 W.S. as the same statutes now exist and as they may from time to time be amended.

This Section does not apply to a qualified person as a self-insurer pursuant to §31-9-414 W.S. as such law now exists or as the same may from time to time be amended.

Section 6. Penalty For Violations. A person convicted of a violation of any section of this Ordinance shall be punished by a fine of not more than Seven Hundred Fifty Dollars (\$750.00) to which may be added court costs not to exceed Ten Dollars (\$10.00) for each violation of any sections of this Ordinance. However, no person charged with a violation of Section 1 or Section 5 of this Ordinance shall be convicted if he or she produces in court a valid driver's license previously issued to him or her and valid at the time of his or her arrest or if said accused produces in court an insurance identification card

issued pursuant to §31-8-201 W.S. valid at the time of his or her arrest.

Section 7. Effective Date. This Ordinance shall be in full force and effect ten (10) days following its passage and approval on final reading.

Section 8. Conflict Clause. Any and all other ordinances of the Mills Municipal Code in conflict herewith are hereby repealed.

Section 9. Invalidity Clause. If any section, paragraph, clause, or provision of this Ordinance shall, for any reason, be held to be invalid or unenforceable, the invalidity or unenforceability of such section, paragraph, clause, or provision shall not affect the remaining provisions of this Ordinance.

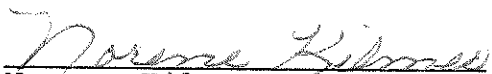
