ORDINANCE NO. 408

AN ORDINANCE AMENDING MILLS TOWN CODE SECTION 6 (B) RELATING TO VICIOUS ANIMALS

WHEREAS, it is desirable to amend Section 6(B) of the Mills Town Code to incorporate the use of tattooing of vicious animals for identification purposes.

NOW, THEREFORE, BE IT ORDAINED BY THE GOVERNING BODY OF THE TOWN OF MILLS, WYOMING:

SECTION 1.

Town Code Section 6(B) is hereby amended to read as follows: Section 6(B). Vicious Animals.

(B) IF THE COURT UNDER THIS SUBSECTION DOES NOT ORDER A DOG DESTROYED, THE OWNER OF SAID DOG SHALL, WITHIN TEN (10) DAYS, PROVIDE PROOF TO THE COURT THAT SAID DOG HAS BEEN PERMANENTLY MARKED WITH A READABLE IDENTIFYING TATTOO. THE TATTOO SHALL BE ONE DESIGNATED BY METRO ANIMAL CONTROL AND SHALL BE PLACED INSIDE THE LEFT EAR, UNLESS IT WOULD BE UNREADABLE IN THAT LOCATION, IN WHICH CASE IT WILL BE PLACED IN THE LEFT FLANK OF THE BACK LEG. ANY EXPENSES INCURRED IN CONNECTION WITH TATTOOING SHALL BE BORNE BY THE PET OWNER OR HIS AGENT. TATTOOING SHALL BE DONE EITHER BY A LOCAL VETERINARIAN OR A METRO ANIMAL CONTROL OFFICER.

SECTION 2.

This ordinance shall be in full force and effect from and after its passage on three readings, publication, and approval, as provided by law.
