AN ORDINANCE TO AMEND \$13.08.160 OF MILLS MUNICIPAL CODE PERTAINING TO CHARGES FOR SEWER SERVICE: ADDING A SECTION ESTABLISHING A SURCHARGE TO BE MADE AGAINST OWNERS AND RESIDENTS OF THE AMBER VALLEY SUBDIVISION

WHEREAS, Amber Valley Subdivision (hereafter Amber Valley) located on the real property described on Exhibit A attached hereto and by this reference incorporated herein situated in the Town of Mills, Natrona County, Wyoming; has private sewer mains, lines, and manholes connecting the individual lots, residences, and apartments to the Town of Mills sewer mains in Mills' streets; and

WHEREAS, the private sewer mains, lines, and manholes connecting to the Town system were either improperly installed, have settled or otherwise do not properly function; and

WHEREAS, when not functioning, sewage backs up into the private system and eventually plugs the private sewer mains, lines, and manholes creating a safety and health hazard; and

WHEREAS, when this safety and health hazard occurs, the individual owners and those responsible for the private sewer system, although responsible to correct the problem, have failed, refused, or neglected to do so thereby necessitating the use of the Town of Mills equipment and manpower to clear the private sewage system; and

WHEREAS, this is a recurring safety and health problem for which the Town incurs substantial cost without recovery.

NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND TOWN COUNCIL OF THE TOWN OF MILLS, WYOMING:

Section 1. Surcharge Created. There is hereby created a surcharge for sewer service for all sewer service users in the Amber Valley Subdivision of \$2.00 per month to be paid in addition to the customary sewer service charge specified by \$13.08.160, Mills Municipal Code. The sewer service charge for Amber Valley residents and owners shall be charged for and collected along with the routine sewer service bills and shall
