

ORDINANCE NO. 420

AN ORDINANCE TO AMEND §13.04.060 OF MILLS MUNICIPAL CODE PERTAINING TO THE WATER FEE AND RATES FOR HOUSEHOLDERS AND §13.04.090 PERTAINING TO WATER FEES AND RATES FOR INDUSTRIAL USERS.

WHEREAS, the Town Council at the regularly scheduled budget hearings conducted on January 18, 1994 and February 16, 1994 determined that an increase in the fees charged for water was necessary; and

WHEREAS, the Council after discussion and review of the present fees agreed that the water rate fee should be increased across the board an amount of \$.15 over the rates previously charged as set out in Section 13.04.060 and 13.04.090, Mills Municipal Code.

BE IT ORDAINED BY THE TOWN COUNCIL OF MILLS, WYOMING that Ordinance 348, Section 3, 1983, published as Section 13.04.060 and 13.04.090, of the Mills Municipal Code, be in the same hereby is repealed and re-enacted to read as follows:

13.04.060 Rates for residential users. The water fee for residential users shall be ten dollars and fifty cents for each quarter year, which fee is considered payment in full for six thousand gallons of water, or any part thereof, consumed by the residential users in any one quarter. All water over and above six thousand gallons per quarter consumed by a residential user shall be charged for at the rate of seventy five cents per thousand gallons.


13.04.090 Rates for industrial users. The water fee for industrial users, and for those who consume water for other than residential or domestic irrigation purposes, or who employ piping and meters larger than three-quarter inch for the conveyance and measuring of water, shall be twenty-four dollars for each quarter year, which fee shall be considered as payment in full for nine thousand gallons of water, or any part thereof, consumed in any one quarter year. All water, over and above nine thousand gallons per quarter consumed by a commercial user, shall be charged for at the rate of ninety-three cents per thousand gallons.

PASSED ON SECOND READING the 7th day of September 1994.

PASSED, APPROVED, and ADOPTED on THIRD and FINAL READING the 7th day of December 1994.
