ORDINANCE NO. 421

AN ORDINANCE TO AMEND §13.04.020 OF MILLS MUNICIPAL CODE PERTAINING TO THE FEE FOR TURNING ON WATER.

WHEREAS, the Town Council at the regularly scheduled budget hearings conducted on January 18, 1994 and February 16, 1994 determined that an increase in the fee charged for turning on water was necessary; and

WHEREAS, the Council after discussion and review of the present fee agreed that the turn on fee should be increased to an amount of \$5.00 or an increase of \$3.00 over the rates previously charged as set out in Section 13.04.020 of the Mills Municipal Code.

BE IT ORDAINED BY THE TOWN COUNCIL OF MILLS, WYOMING that Ordinance 242, Section 1, 1976, published as Section 13.04.020, of the Mills Municipal Code, be in the same hereby is repealed and re-enacted to read as follows:

13.04.020 Fee for turning on water—Compliance with regulations. Any entity wishing to use water from the Mills municipal water system shall request the town water department office turn the water into lines providing the water service, for which it shall pay five dollars fee to the Town Clerk. The water user shall thereafter pay to the town the regular water use fees, as are hereinafter established, and shall abide by, all rules and regulations established by the town concerning the dispensation of water from the municipal water system.
