ORDINANCE NO. 422

AN ORDINANCE TO AMEND §6.04.190 OF MILLS MUNICIPAL CODE PERTAINING TO COLLECTION FEES FOR GARBAGE AND WASTE MATTER COLLECTION.

WHEREAS, the Town Council at the regularly scheduled budget hearings held on January 18, 1994 and February 16, 1994 determined that an increase in the fees charged for garbage and waste matter collection was necessary; and

WHEREAS, the Council after discussion and review of the present fees agreed that the collection fees should be increased an amount of \$.50 over the rates previously charged as set out in \$6.04.190 of the Mills Municipal Code.

BE IT ORDAINED BY THE TOWN COUNCIL OF MILLS, WYOMING that Ordinance 384, Section 1, 1989 published as Section 6.04.190 Mills Municipal Code be hereby repealed and re-enacted to read as follows:

- §6.04.190 Garbage collection fees. A. Each residence or business located within the town shall be charged a minimum of five dollars per month for which the town shall collect and dispose of two fifty-five gallon barrels of garbage, or an equivalent amount, once each week.
- B. For garbage collections over the minimum, the town will charge two dollars and fifty cents per barrel or equivalent amount.
- C. For each three-yard bin garbage container picked up the charge will be twelve dollars and fifty cents per month.
- D. Special request extra garbage pick ups will be charged for at the rate of five dollars and fifty cents per pick up for residential users and eight dollars per pick up for commercial users.
- E. Whenever it is not possible to determine the fees to be charged because the garbage or waste matter is not stored in, or cannot be calculated in, the equivalent of fifty-five-gallon barrels, the mayor or the mayor's representative shall, over a period of not less than one week, conduct a study to determine the fee to be charged. The fee shall be based upon the collection time involved, and the nature and volume of the material collected.
