## ORDINANCE NO. 426

AN ORDINANCE TO AMEND AND RE-ENACT § 10.28.030 OF MILLS MUNICIPAL CODE PERTAINING MAXIMUM LAWFUL SPEEDS.

WHEREAS, the Mills Town Council after discussion at a regularly scheduled council meeting conducted on December 7, 1994 determined that it would be advisable to amend and re-enact ordinance no. 10.28.030 of the Mills Municipal Code to clarify the intention of the Town Council regarding lawful speeds within the Town of Mills;

NOW THEREFORE, the council makes the following change in the Mills Municipal Code;

BE IT ORDAINED BY THE TOWN COUNCIL OF MILLS, WYOMING that Section 10.28.030, of the Mills Municipal Code, be in the same hereby is repealed and re-enacted to read as follows:

10.28.030 Maximum lawful speeds. Except when a special hazard exists that requires lower speeds for compliance with Section 10.28.020, the limits specified in this subsection, or established as otherwise authorized and posted pursuant to W.S. § 31-5-303, shall be the maximum lawful speeds, and no person shall drive a vehicle on the streets or alleys of the town at a speed in excess of the following maximum limits:

- A. Fifteen miles per hour in all alleys;
- B. Twenty miles per hour on all local streets;
- C. Thirty miles per hour on all collector secondary arterial streets, and arterial streets.
