ORDINANCE NO. 429

AN ORDINANCE TO AMEND AND RE-ENACT § 9.32.020 OF MILLS MUNICIPAL CODE PERTAINING TO HEALTH OR FIRE HAZARD --- DECLARED PUBLIC NUISANCE.

WHEREAS, the Mills Town Council after discussion at a regularly scheduled council meeting conducted on August 9, 1995 determined that it would be advisable to amend and re-enact Ordinance No. 9.32.020 of the Mills Municipal Code;

NOW THEREFORE, the council makes the following change in the Mills Municipal Code;

BE IT ORDAINED BY THE TOWN COUNCIL OF MILLS, WYOMING that Section 9.32.020, of the Mills Municipal Code, be in the same hereby is repealed and re-enacted to read as follows:

9.32.020 Health or fire hazard -- Declared nuisance. The accumulation or storage of abandoned, wrecked, dismantled, unlicensed or inoperative vehicles or junk on private or public property is found to create a condition tending to reduce the value of private property, to promote blight and deterioration, to invite plundering, to create fire hazards, to constitute an attractive nuisance creating a hazard to the health and safety of minors, to create a harborage for insects, rodents, skunks and other vermin and to be injurious to the health, safety and general welfare of the public. Therefore, the presence of an abandoned, wrecked, dismantled or inoperative vehicle, or any part or portion thereof, more than one unlicensed vehicle, or junk on private or public property,

except as expressly permitted, is declared to constitute a public nuisance which may be abated as such in accordance with the provisions of this chapter.
