

ORDINANCE NO. 453

AN ORDINANCE CREATING SECTION 10.20.055 OF THE TOWN OF MILLS MUNICIPAL CODE PROHIBITING THE USE OF ENGINE COMPRESSION BRAKES, ALSO KNOWN AS JACOBS ENGINE AND "JAKE" BRAKES, WITHIN THE MILLS TOWN LIMITS.

WHEREAS, the Town of Mills has received complaints from residents concerning their being disturbed by the noise created when someone uses an engine compression brake within the town; and,

WHEREAS, the Town is authorized by Wyoming State Statute to adopt ordinances necessary for the health, safety, and welfare of the Town; and,

WHEREAS, the adoption of an ordinance prohibiting the use of an engine compression brake within the Town is necessary and desirable.

NOW, THEREFORE, BE IT ORDAINED BY THE GOVERNING BODY OF THE TOWN OF MILLS, WYOMING: That Section 9.08.065 of the Town Municipal Code is hereby created to read as follows:

No person shall operate or use any vehicle engine compression brake, jacob's engine brakes or "jake" brakes within the corporate limits of the Town.



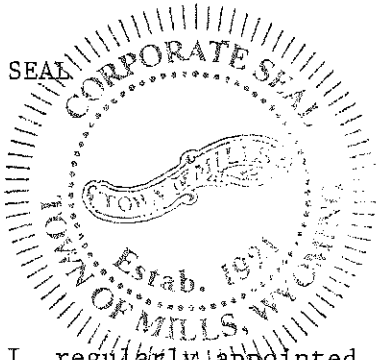
