ORDINANCE NO. ____454__

AN ORDINANCE CREATING SECTION 7.08.150 EXCLUDING AND EXEMPTING POLICE DIVISION CANINES FROM SECTION SOF CHAPTER 7.08 RELATING TO DOG-AT-LARGE, QUARANTINE REQUIREMENTS, AND VICIOUS ANIMALS.

WHEREAS, the Mills Police Division has access to a Police Canine Unit that utilizes trained law enforcement canines to assist the patrol function of the Town of Mills Police Division; and,

WHEREAS, the use of said law enforcement canines for law enforcement responsibilities constitutes a real or implied use of force which may violate sections of the Town of Mills Code, Chapter seven, relating to dog-at-large, quarantine requirements, and vicious animals; and,

WHEREAS, in order for the Police Canine Unit to operate efficiently and effectively, it is necessary to exclude and exempt law enforcement canines from the aforementioned sections of said Chapter seven.

NOW, THEREFORE, BE IT ORDAINED BY THE GOVERNING BODY OF THE TOWN OF MILLS, WYOMING:

Section 7.08.150 of the Town of Mills Municipal Code is hereby created to read as follows:

SECTION 7.08.150 - POLICE CANINE EXCLUSIONS, EXEMPTIONS.

POLICE CANINES WORKING ON DUTY WITH OR AT THE DIRECTION OF LAW ENFORCEMENT PERSONNEL ARE EXCLUDED FROM SECTIONS 7.08.010(7), 7.08.010(17) AND 7.08.010(23); AND, ARE EXEMPTED FROM SECTIONS 7.08.090(C), 7.08.090(D), 7.08.090(E), 7.08.090(F), 7.08.090(G), 7.08.090(J), AND 7.08.080.




