ORDINANCE NO. 472

AN ORDINANCE AMENDING SECTION 13.04.020 OF THE TOWN OF MILLS MUNICIPAL CODE PERTAINING TO FEE FOR TURNING ON WATER - COMPLIANCE WITH REGULATIONS

NOW, THEREFORE, BE IT ORDAINED BY THE GOVERNING BODY OF THE Town OF MILLS, WYOMING:

13.04.020 Fee for turning on water—Compliance with regulations. Any entity person wishing to use water from the Mills municipal water system shall request the town water department office turn the water into the lines providing the water service, for which it shall pay a five-dollar fee to the town clerk. The water user shall thereafter pay to the town the regular water use fees, as are hereinafter established, and shall abide by, all rules and regulations established by the town concerning the dispensation of water from the municipal water system.

In the event any water service shall be discontinued or disconnected due to non-payment of water use fees or other violation of any rules and regulations provided in this Chapter, such person shall not be eligible to receive continued water service until such person shall pay to the town clerk a twenty-five dollar fee for reinstatement of the water service. Upon a second and subsequent discontinuation or disconnection such person shall pay a fifty dollar fee for reinstatement of the water service. (Ord. 421, 1994)
