

AN ORDINANCE AMENDING SECTION 6.04.210  
OF THE TOWN OF MILLS MUNICIPAL CODE PERTAINING TO  
HEALTH AND SANITATION - GARBAGE - ACCUMULATION - ORDER FOR REMOVAL  
IN THE TOWN OF MILLS, WYOMING AND DECLARING AN EMERGENCY

WHEREAS, the Town of Mills, Wyoming, by and through its duly appointed Clean-up Committee, is undertaking efforts to insure property owners cut weeds and other noxious vegetable growth and clean-up garbage, waste material and junk to protect the public health, safety and welfare, and

WHEREAS, due to near-drought conditions and increased fire hazard, the immediate preservation of the public peace, health, safety and welfare of the residents would be served by the immediate adoption of the following ordinance:

NOW, THEREFORE, BE IT ORDAINED BY THE GOVERNING BODY OF THE TOWN OF MILLS, WYOMING:

GARBAGE

SECTION 1:

Section 6.04.210 of the Town of Mills, Wyoming Municipal Code pertaining to Health and Sanitation - Garbage - Accumulation - Order for Removal is hereby amended to provide as follows:

Section 6.04.210. Accumulation - Order for Removal - Lien.

Whenever the Town of Mills Clean-up Committee ~~town council~~ shall direct, the Committee ~~town clerk~~ shall immediately thereafter notify any owner of property, his agent or any person having charge of such property, in writing, that an order has been made by the Committee ~~town council~~ requiring the removal of any accumulated refuse, garbage or other waste material from such property or premises within ten ~~thirty~~ days after service of notice. If such property owner, agent or person having charge of such property, shall not remove such refuse in accordance with the requirements of such order, the Committee ~~town council~~ may order that such refuse be removed by the town, or agents of the town, and assess the cost thereof against the owner of the property or premises, or against the property as if a lien for improvement of the property, in which case the town may proceed against the property in accordance with the applicable lien foreclosure statutes. SECTION 2: REPEAL OF CONFLICTING ORDINANCES

All existing Ordinances or parts of Ordinances of the Town of Mills are hereby repealed insofar as they may be inconsistent with the provisions of this Ordinance.

SECTION 3. SEPARABILITY OF PROVISIONS

It is the intention of the Council that each separate provision of this Ordinance be deemed independent of all other provisions, and it is further the intention of the Council that if any provisions of this Ordinance be declared invalid for any reason that all other provisions hereof shall remain valid and enforceable.

SECTION 4:

Pursuant to W.S. §15-1-115(c) for an emergency Ordinance, the requirements relating to public readings and the ten (10) day elapse between introduction and passage may be suspended by the affirmative vote of three-fourths of the qualified members of the governing body; and, pursuant to

W.S. §15-1-115(d), the passage of an emergency Ordinance requires the affirmative vote of three-fourths of the qualified members of the governing body.

SECTION 5:


Pursuant to W.S. §15-1-105(a)(iii), an emergency Ordinance means an Ordinance operating for the immediate preservation of the public peace, health, safety or welfare, in which the emergency is defined.

SECTION 6:


For the reasons set forth in the preamble of this Ordinance, the Council finds and declares that an emergency exists; that this Ordinance is for the immediate preservation of the public peace, health, safety and welfare, and that it shall be in full force and effect immediately upon its approval.

PASSED, APPROVED, AND ADOPTED on the 8th day of August, 2001.

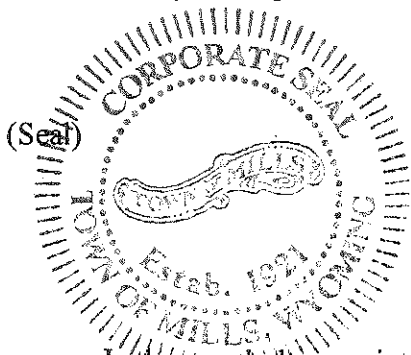



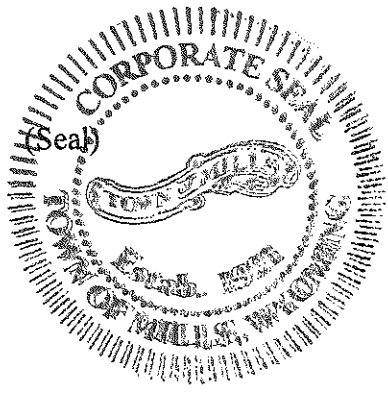
