

AN ORDINANCE CREATING SECTION 10.28.060 OF THE MILLS MUNICIPAL CODE PROHIBITING UNAUTHORIZED SPEED OR ACCELERATION CONTESTS OR EXHIBITIONS ON HIGHWAYS OR ROADWAYS IN THE TOWN OF MILLS, WYOMING

WHEREAS the Town of Mills, Wyoming has adopted certain ordinances pertaining to the traffic rules and regulations for motor vehicles within its jurisdiction;

WHEREAS the public health, safety, and welfare will be served by the establishment of compliance for speed or acceleration contests or exhibitions on highways or roadways in order to better serve the residents of the Town of Mills, Wyoming;

NOW, THEREFORE, BE IT ORDAINED BY THE GOVERNING BODY OF THE TOWN OF MILLS, WYOMING:

SECTION 1: SPEED OR ACCELERATION CONTEST OR EXHIBITION ON HIGHWAYS OR ROADWAYS IN THE TOWN OF MILLS, WYOMING

(a) No person shall engage in any motor vehicle speed or acceleration contest, or exhibition of speed or acceleration on any roadway, street or highway without approval of such use by the governing body in charge of said roadway, street or highway. No person shall aid or abet in any such motor vehicle speed or acceleration contest or exhibition on any roadway, street or highway, without approval of such use by the governing body in charge of said roadway, street or highway.

(b) No person shall for the purpose of facilitating or aiding or as an incident to any motor vehicle speed or acceleration contest upon a roadway, street or highway, in any manner obstruct or place or assist in placing any barricade or obstruction upon any roadway, street or highway without approval of such use by the governing body in charge of said roadway, street or highway.

(c) Any person who violates this section shall upon conviction be fined in any amount not to exceed seven hundred fifty dollars (\$750).

SECTION 2. EFFECTIVE DATE

This Ordinance shall be in full force and effect ten (10) days following its passage and approval on third and final reading.

SECTION 3. REPEAL OF CONFLICTING ORDINANCES

All existing Ordinances or parts of Ordinances of the Town of Mills are hereby repealed insofar as they may be inconsistent with the provisions of this Ordinance.

PASSED on 2nd reading the 3rd day of October, 2001.

PASSED, APPROVED, AND ADOPTED on the 3rd and final reading on the 7th day of November, 2001.

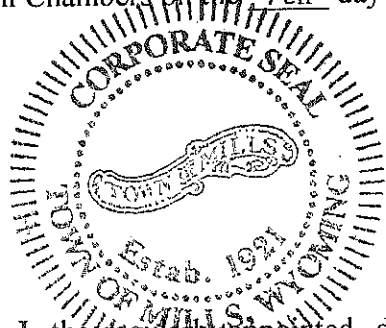

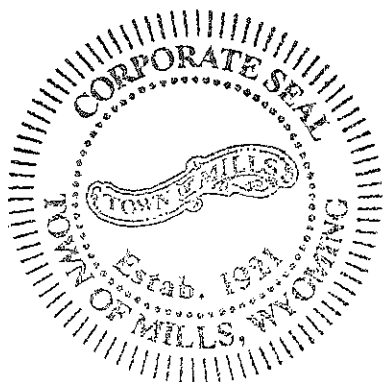
