ORDINANCE NUMBER FORTY-EIGHT-B

PROVIDING FOR THE AMENDMENT OF ORDINANCE NUMBER FORTY-EIGHT-A, WHICH IS AN ORDINANCE PROVIDING FOR THE AMENDMENT OF ORDINANCE NUMBER FORTY-EIGHT.

BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF MILLS, WYOMING:

SECTION 1. -- AMENDING ORDINANCE NUMBER FORTY-EIGHT-A. That Ordinance Number Foty-Eight-A, which is an ordinance providing for the amendment of Ordinance Number Forty-Eight shall be, and is, hereby amended and re-enacted to read hereafter as follows:

That Ordinance Number Forty-eight, which is an ordinance providing for the regulation, prohibition and license of the sale of alcoholic and malt liquor, shall be, and is hereby amended to the extent that action Seven of the said Ordinance Number Forty-eight shall hereafter read as follows: Section 7.— Every person licensed under the provisions of this ordinance as a retail liquor dealer, shall pay annually for a license hereunder, the sum of five hundred dollars; provided that any such retail liquor dealer who shall dispense liquor for consumption upon the premises or who shall furnish his patrons with bar service, shall be required to pay the sum of seven hundred fifty dollars annually as aforesaid, and that the said license fee shall be paid in full to the town treasurer before the issuance of any license for the retail sale of alcoholic liquor within the town of Mills.

SECTION 2.-- REMAINDER OF ORDINANCES FORTY-EIGHT AND FORTY-EIGHT -A TO REMAIN UNALTERED. That Ordinance Number Forty-eight and Number Forty-eight-A shall remain as written, except for the amendment herein specified.

SECTION 3.-- THAT THIS OFDINANCE SHALL TAKE EFFECT AND BE IN FORCE AFTER TEN DAYS FROM DATE.
