ORDINANCE NO. 493

AN ORDINANCE ESTABLISHING THE PAY FOR THE MAYOR OF THE TOWN OF MILLS AND THE PAY FOR EACH COUNCIL PERSON OF THE TOWN OF MILLS; ESTABLISHING AN EFFECTIVE DATE; AND AMENDING OR REPEALING ORDINANCES IN CONFLICT HEREWITH.

NOW, THEREFORE, BE IT ORDAINED BY THE GOVERNING BODY OF THE TOWN OF MILLS, WYOMING:

SECTION 1: SALARY OF MAYOR/HOURS OF SERVICE

The Mayor of the Town of Mills, Wyoming is expected to devote a minimum of hours of service per week to the Town of Mills, Wyoming. The salary to be paid to the Mayor of the Town of Mills shall be Twelve Thousand Dollars (\$12,000.00) per year, payable in twelve (12) equal monthly installments of One Thousand Dollars (\$1,000.00). In the event the Mayor does not work the minimum number of hours for the Town of Mills, Wyoming prescribed in this section, the salary of the Mayor shall be reduced in proportion to the number of hours actually worked.

SECTION 2. SALARY OF COUNCIL PERSONS

The salary for each Council Person shall be Fifty Dollars (\$50.00) for actual attendance at each regular or special meeting of the Council.

SECTION 3. EFFECTIVE DATE

This Ordinance shall be in full force and effect ten (10) days following its passage and approval on third and final reading; however, the provisions of this Ordinance shall not be given retroactive effect with regard to any present council Person or Mayor duly elected and serving at the time of the passage of this Ordinance but shall only affect compensation or salary to be paid to the office of Mayor and Council persons after the next election for each such office.

SECTION 4. REPEAL OF CONFLICTING ORDINANCES

All existing Ordinances or parts of Ordinances of the Town of Mills are hereby repealed insofar as they may be inconsistent with the provisions of this Ordinance.

SECTION 5. SEPARABILITY OF PROVISIONS

It is the intention of the Council that each separate provision of this Ordinance be deemed independent of all other provisions, and it is further the intention of the Council that if any provisions of this Ordinance be declared invalid for any reason that all other provisions hereof shall remain valid and enforceable.
