

ORDINANCE NO. 508

AN ORDINANCE AMENDING ORDINANCE NO. 506
PERTAINING TO THE BUDGET OF THE TOWN OF MILLS, WYOMING

WHEREAS THE TOWN OF MILLS, WYOMING, Ordinance No. 506 pertaining to the budget of the Town of Mills, Wyoming, contained errors or omission with respect to the budget of various departments within the Town of Mills, and

WHEREAS the Town has surplus funds available to provide for the budget amendments herein.

NOW, THEREFORE, BE IT ORDAINED BY THE GOVERNING BODY OF THE TOWN OF MILLS, WYOMING: that Ordinance 506 shall be and hereby is amended to provide as follows:

ANNUAL APPROPRIATION ORDINANCE FOR THE FISCAL YEAR ENDING JUNE 30, 2004
