

ORDINANCE 511

AN ORDINANCE ESTABLISHING SEWER AND SANITATION RATES FOR THE
TOWN OF MILLS,
NATRONA COUNTY, WYOMING

WHEREAS the Town wishes to provide better service to property owners and tenants within the town; and

WHEREAS the Town considers it to be a significant improvement of service to provide owners and tenants with a pass to use the City of Casper bale fill through the Mills water bill,

NOW, THEREFORE, BE IT ORDAINED BY THE GOVERNING BODY OF THE TOWN OF MILLS, WYOMING:

SECTION 1 ANNEXED RESIDENTIAL SEWER AND SANITATION RATES:

Sanitation rates for the Town residential customers are hereby established to be thirty dollars (\$30.00) per month quarter (formerly \$24) for residential service.

SECTION 2 ANNEXED COMMERCIAL SEWER AND SANITATION RATES:

Sanitation rates for the Town commercial customers are hereby established to be thirty dollars (\$30.00) per quarter for up to two (2) barrels and sixty dollars (\$60.00) per quarter for each dumpster emptied once each week. Sewer rates for the Town commercial customers are hereby established to be thirty-six dollars (\$36.00) per quarter for up to 6,000 gallons and a charge of twenty-five cents (\$0.25) per 1,000 gallons over the base 6,000 gallons.

SECTION 3 EXTRA-TERRITORIAL RESIDENTIAL SEWER RATES:

Sewer rates for residential properties outside the Town limits are hereby established to be forty-five dollars (\$45.00) per quarter formerly \$36.00.

SECTION 4 EXTRA-TERRITORIAL COMMERCIAL SEWER RATES:

Sewer rates for commercial properties outside the Town limits are hereby established to be fifty-two dollars and fifty cents (\$52.50) per quarter for up to 6,000 gallons and a charge of thirty-eight cents (\$0.38) per 1,000 gallons over the base 6,000 gallons.

SECTION 2 5 USE OF CASPER LANDFILL:

Each quarterly billing will contain three punches to be used by the payer of the bill at the Casper balefill. These punches will allow the payer to haul trash and garbage to the Casper landfill and dispose of it there with no additional charge. This program is subject to the rules and regulations of the Casper balefill concerning oversize loads, hazardous waste and other requirements.

SECTION 3 6 BILLING CYCLE:

The quarterly billing cycle shall remain in effect for sewer and sanitation.

SECTION 4 7 EFFECTIVE DATE:

The water rates hereinabove listed shall become effective immediately upon passage of this Ordinance.

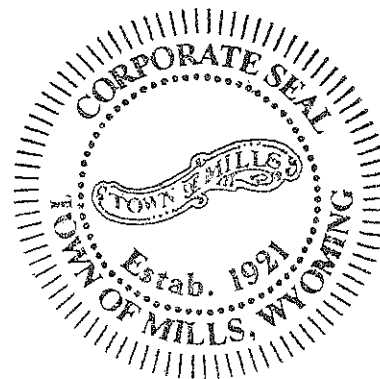

PASSED, APPROVED, AND ADOPTED on the 3rd and final reading on the 9th day of Mar, 2005.






