

ORDINANCE NO. 517

Chapter 2.04

AN ORDINANCE AMENDING SECTION 2.04.010 OF THE TOWN OF MILLS MUNICIPAL CODE PERTAINING TO TIME AND PLACE OF COUNCIL MEETINGS

WHEREAS the Town Council wishes to change the time of its regular meetings, and

WHEREAS it is necessary to provide a procedure to hold the regular meetings of the Mills Town Council on an alternate date in cases where the Mayor or other council members cannot attend the regular meetings, and

NOW, THEREFORE, BE IT ORDAINED BY THE GOVERNING BODY OF THE TOWN OF MILLS, WYOMING SECTION 2.04.010 OF THE MILLS MUNICIPAL CODE IS HEREBY AMENDED AS FOLLOWS:

SECTION 1:

2.04.010 Time and place of meetings. Regular meetings of the town council shall be held on the first Wednesday of each month, unless the first Wednesday falls upon the first or second day of the month, in which event the regular meeting shall be held on the second Wednesday of the month. Regular meetings shall commence at ~~seven-thirty~~ **seven o'clock 7:00** p.m. and be held at the council chambers, ~~405 Wasatch~~ 704 4th Street or at any other place designated according to law. ~~There shall be, in addition to the regularly scheduled council meetings, one additional council meeting to be held later in each and every month, the time, place and date of which will be designated at the regularly scheduled council meeting of each month.~~ (Ord. 216 §1, 1973; Ord. 166 §1, 1966.)

In the event the Mayor or a quorum of Council members shall be unable to attend the regular meeting of the Town Council due to illness, scheduling conflicts, or any other reason, the Council may elect to hold its regular meeting at another date and time as determined by the Council. In the event any regular meeting of the Town Council is rescheduled as provided herein, the Town Clerk shall cause a notice of the date and time of such meeting to be published in a newspaper of general circulation at least fifteen (15) days before the date of the rescheduled meeting and shall post a notice of the rescheduled meeting in the Town Hall at least fifteen (15) days before the date of the rescheduled meeting.


In the event the Council desires to hold any additional or special meetings, the Council shall specify the date, time and place of any such special meeting at the regularly scheduled Council meeting of each month.

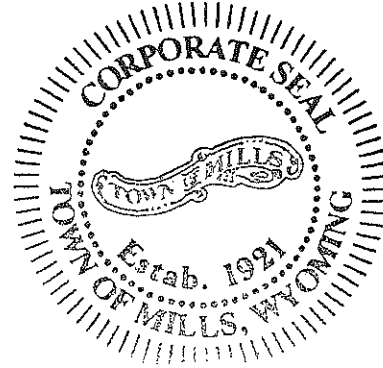

PASSED on 2nd reading the 3 day of August, 2005.


PASSED, APPROVED, AND ADOPTED on the 3rd and final reading on the 7 day of September, 2005.




