### ORDINANCE NO. 533

# AN ORDINANCE AMENDING SECTIONS 7.08.010 AND 7.08.100 OF THE MILLS MUNICIPAL CODE PERTAINING TO ANIMALS

## NOW, THEREFORE, BE IT ORDAINED BY THE GOVERNING BODY OF THE TOWN OF MILLS, WYOMING:

#### Section 1:

Section 7.08.010 of the Mills Municipal Code shall hereby be amended to include as follows:

- 27. "Wild animal" or "exotic pet" shall mean any live:
  - A. Monkey (nonhuman primate).
  - B. Raccoon.
  - C. Skunk.
  - D. Fox.
  - E. Wolf or Wolf hybrid.
  - F. Venomous snake.
  - G. Leopard, Panther, Lion or Lynx.
  - H. Coyote.
  - I. All amphibians in the following amphibian families:
    - 1. Cane Toad.
    - 2. Poison Dart Frog of the genus Dendrobates or Epibates.
  - J. Venomous reptile.
  - K. Crocodilian.
  - L. All spiders contained in the following spider families:
    - 1. Black widow.
    - 2. Hobo.
    - 3. Recluse.
    - 4. Balboa.
    - 5. Wandering Huntsman.
    - 6. Funnel Web.
    - 7. Australian White Rump and the Australian White Tailed.
  - M. All of the following scorpion species:
    - 1. Buthus,
    - 2. Parabuthus.
    - 3. Androctonus.
    - 4. Leiurus Quinquestriatus.
    - 5. Centuroides.
    - 6. Hottentotta.
    - 7. Mesobuthus.
  - N. All Centipedes.

- O. All Monitors exceeding three (3) feet in overall length.
- P. All Boa and Python snakes.
- Q. Any other animal which can normally be found in the wild state.

Section 2:

Section 7.08.100 of the Mills Municipal Code shall hereby be amended to read as follows:

A. Except as otherwise provided, it is unlawful for any person to intentionally own or possess, or possess with the intention of selling any wild animal or exotic pet within the corporate city limits of Mills, Wyoming, except that this section shall not apply to the keeping of small cage-birds or aquatic fish, or small rodents, including, but not limited to, hamsters, guinea pigs or gerbils solely as pets, nor to any zoological garden, theatrical exhibit or circus, as defined in Section 6.04.010 of this chapter, any legally incorporated and accredited college, university or school, or any governmental research laboratory.

#### Section 3:

This ordinance shall be in full force and effect from and after passage on three readings, and after publication.
