

ORDINANCE NO. 539

AN ORDINANCE AMENDING CHAPTER 9.20 PERTAINING TO  
NARCOTICS IN THE TOWN OF MILLS

NOW, THEREFORE, BE IT ORDAINED BY THE GOVERNING BODY OF THE TOWN OF MILLS, WYOMING, THAT CHAPTER 9.20 OF THE MILLS MUNICIPAL CODE BE AND HEREBY IS AMENDED AND REPLACED WITH THE FOLLOWING:

Sections:

- 9.20.010 Possession of drugs
- 9.20.020 Possession of paraphernalia
- 9.20.030 Penalty for violation

9.20.010 Possession of drugs. It is unlawful for any person or persons to have in his possession, sell, dispose of, give away or receive any ~~cocaine, eucaine, pot eucaine, alpha eucaine,~~ morphine, heroin, ~~chloral, chloral hydrate, Indian hemp, opium,~~ **controlled substance as defined by §W.S. 35-7-1002 et. seq.,** or any salt, compound or derivative thereof except by a prescription of a licensed practicing physician registered in this state, for the full amount found in the possession of the person. (Ord. 32 §1, 1923).

9.20.020 Possession of paraphernalia. It is unlawful for any person or persons to willfully use or possess with intent to use any paraphernalia, equipment or device to cultivate, grow, harvest, manufacture, prepare, produce, process, test, analyze, package, re-package, store, conceal, inject, ingest, inhale or otherwise introduce into the human body any controlled substance.

9.20.030 Penalty for violation. Any person or persons ~~in any way or manner selling disposing of, giving away, receiving or having in his possession any of the above mentioned narcotics upon conviction~~ **convicted of violating any of the provisions of this chapter** shall be deemed guilty of a misdemeanor and punished as provided in section 1.01.115. (Ord. 222 §2 (part), 1973; Ord. 32 §2, 1923).


