ORDINANCE NUMBER----55 ESTABLISHING GOVERNMENT OF COMMUNITY HOUSE. BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF MILLS: SECTION I .--- COMMUNITY HOUSE TO BE MANAGED AND CONTROLED BY COMMITTEE COMMITTEE TO CONSIST OF THREE
PEOPLE AND APPROVED BY TOWN COUNCIL. That, there shall be
Established a Special Committee, Consisting of Three Persons, to have

The Management and Control of the Community Building, Charge of the Management and Control of the Community Building, Situated on Lots I5 & I6, in Block I5, on Midwest Avenue, in this Town, and Generally Known as the "MILLS Community House"; such Committee to be Named by a Vote of the People of the Town of MILLS and Approved by the Town Council as Hereinafter Provided, and to be Known as the "Committee in Charge of Community Force". in Charge of Community House, COMMETTEEMEN TO BE TAKEN AT GENERAL TOWN MEETING. VORE F SECTION 2. ---PROVIDED FOR, DATES NAMED, MANNER OF HOLDING MEETINGS SRECTY That, On or About February Ist, 1944, the Committee in Charge of Community House shall Cause to be held in said Community House a General Town Meeting to which Every Resident of the Town of MILLS shall have been Invited by Indivual, Written Invitation Bearing the Signatures of all of the Members of said Committee, for the Express Purpose of Holding an Election of Three Persons to Serve as Members of the Committee in Charge of Community House for Terms which shall be Specified upon the Ballots as Follows: One Person for a Period of One Year, One Person for a Period of Two Years, and One Person for a Period of Three Years; and on or About the Same Date Aforesaid, in Every Ensuing Year, the Aforesaid Committee shall Cause a General Town Meeting to be Held at the same Place, Invitations to which shall have been Sent out as Specified Elsewhere in this Section, for the Purpose of Fleeting One Person to fill the Place on said Commi for the Purpose of Electing One Person to fill the Place on said Committee Vacated by the Member whose Term Expires at that time. And when such Election shall have been Held and the Appointee, Or Appointees, Named as Herein Directed, the Town Council shall at its Next Regular Meeting Formally Approve and Affirm such Appointments. SABERNISTON SECTION 3. -- CHAIRMANSHIP OF COMMITTEE ---

PERSONS ENTERING UPON THIRD YEAR NO BE CHAIRMAN --- COMMITTEE SUBJECT TO SUPERVISION BY COUNCIL. That, the Chairmanship of said Committee shall be Changed Each Year, the Person Entering upon his Third Year on the Committee to Automatically Assume Chairmanship Thereof; Except that Following the 1944 Election it shall be the Person elected for a Period of One Year who shall be the Chairman, and Following the 1945 Election, the Person then Entering upon his Second Year as a Member of said Committee shall Assume the Chairmanship. That, in the Discharge of its Official Duties the said Committee is to be at All Times Subject to Supervision and Control by the Town Council, as Provided in the State Law Governing Appointed Town Officers, Section 22-1421, Wyoming Revised Statutes. SECTION 4. --- TERM OF OFFICE OF COMMITTEEMEN -- REMOVAL -- FILLING OF

VACANCY ----WITH CERTAIN EXCEPTIONS, COMMITTEEMEN TO SERVE FOR THREE

YEARS, OR UNTIL SUCCEEDED OR REMOVED. That, Except as Otherwise Provided in a Preceeding Section of this Ordinance, the Term of Office of Each Member of the Committee in Charge of Community House shall be for a period of Three Years, or Until his Successor is duly Elected and

SECTION 4---- Continued

Approved as Herein Provided: Except that Any Committeenam who is Elected to Any Town Office shall be Automatically Dropped from Membership in said Committee; and that Any Committeeman may, at any Time, for Reasonable Cause as Set Forth in the Ordinance Governing Appointed Town Officials, be Removed from Office by a Vote of Three -- Fourths of All of the Councilmen.

FILLING OF VACANCIES PROVIDED FOR. And in the case of a Vacancy Occuring in the Membership of said Committee, from Any Cause Whatsoever, the Two Remaining Committeemen shall Name a Person to Fill such Vacancy for the Remainder of the Unexpired Term; but in the Case of a Vacancy Occuring in said Committee and the Two Remaining Members Being Unable to Agree upon Any Appointee to Fill the Same, the Town Council shall then Make such Appointment; said Appointee to Serve Until his Successor is Elected the same as Other Committeemen.

SECTION S. LA REPRISES OF COMMUNITY HOUSE PROVIDED FOR

Town of MILLS TO FURNISH WATER, COMMITTEE TO DEFRAY OTHER EXPENSES.
That, Water for Use in said Community House shall be Furnished from the
Municipal Water System, Free of Charge; but that All Other Costs of
Administration, Including the Expense of Providing Fire Insurance
Coverage for said Community House, shall be Defrayed by the Committee in Charge out of Monies Accrued from Various Sources to the Building Fund.

SECTION 6 .--- CERTAIN ACTIVIES FORBIDDEN IN COMMUNITY HOUSE

COMMITTEE IN CHARGE TO SHOW NO PARTIALITY, TO BROWIEIT PROFIT+

TAKING AND INDECENT CONDUCT. TO CALL MARSHALL IN CASE OF DISORDER. That, it shall be Unlawful and Expressly Forbidden for any Berson. Persons, Groups, or Organization to Make Use of Community House for Other than Strictly Non-Profit Affairs; that no Lewd, Licentious, Indecent or Disorderly Conduct shall be Permitted to Take Place on the Premises, and that any Committeeman Having Knowledge of any Infraction of any of the Aforesaid Restrictions shall order the Same to be Immediately Discontinued and Refrained from and shall then Immediately Call the Town Marshal to Enforce said Order; and that, in their Adminstration and Management of Community House, the Committee in Charge is Strictly to Show no Partiality to any Group Organization or Club.
