

ORDINANCE # 552

AN ORDINANCE APPROVING THE VACATION AND REPLAT OF LOTS 4 AND 21, PETERSON ADDITION NO. 2, AND LOTS 1-3, THE N1/2 OF LOT 4, THE SOUTH 10' LOT 11, LOTS 12-17, BLOCK 8, KISKIS ADDITION, AND A PORTION OF THE NW1/4NE1/4, SECTION 12, TOWNSHIP 33 NORTH, RANGE 80 WEST, 6TH P.M., TOWN OF MILLS, WYOMING; INCLUDING A VACATION OF THE PUBLIC WAY EXTENDING NORTHWARD FROM CONNIE STREET TO NATRONA AVENUE, TO FORM LOTS 1-2, BLOCK 1 AND LOTS 1-5, BLOCK 2, DELMAR ADDITION, TOWN OF MILLS, WYOMING.

WHEREAS, there has been submitted to the Mills Planning and Zoning Board an application for approval of a replat and vacation of a portion of Lots 4 and 21, Peterson Addition No. 2, and Lots 1-3, the N1/2 of Lot 4, the south 10' Lot 11, Lots 12-17, Block 8, Kiskis Addition, and a portion of the NW1/4NE1/4, Section 12, Township 33 North, Range 80 West, 6th P.M., Town of Mills, Wyoming; including a vacation of the public way extending northward from Connie Street to Natrona Avenue, to form Lots 1-2, Block 1 and Lots 1-5, Block 2, Delmar Addition, Town of Mills, Wyoming.; and

WHEREAS, the Town staff have reviewed the information submitted and found that replat complies with the Town of Mills zoning and subdivision regulations; and;

WHEREAS, the Planning and Zoning Board reviewed and forwarded a "Do Pass" recommendation of the replat at their meeting on April 2, 2009; and,

NOW, THEREFORE, BE IT ORDAINED BY THE GOVERNING BODY OF THE TOWN OF MILLS, WYOMING:

The Town of Mills hereby vacates and replats Lots 4 and 21, Peterson Addition No. 2, and Lots 1-3, the N1/2 of Lot 4, the south 10' Lot 11, Lots 12-17, Block 8, Kiskis Addition, and a portion of the NW1/4NE1/4, Section 12, Township 33 North, Range 80 West, 6th P.M., Town of Mills, Wyoming; including a vacation of the public way extending northward from Connie Street to Natrona Avenue, to form Lots 1-2, Block 1 and Lots 1-5, Block 2, Delmar Addition, Town of Mills, Wyoming.;

PASSED on 1st reading the 8 day of April, 2009.

PASSED on 2nd reading the 6 day of May, 2009.

PASSED, APPROVED, AND ADOPTED on the 3rd and final reading on the 3 day of JUNE, 2009.

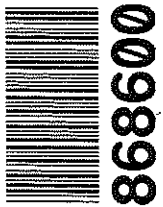




