

ORDINANCE NUMBER FIFTY-FIVE B

AN ORDINANCE AMENDING AND RE-EMACTING SECTION 12 OF ORDINANCE NUMBER FIFTY-FIVE A, RELATING TO THE RENTING OF THE MILLS COMMUNITY HALL.

BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE TOWN OF MILLS, WYOMING:

SECTION 1.-- That Section Twelve of Ordinance Number Fifty-five A, be amended and re-enacted to read as follows:

Section 12.-- RENTING OF COMMUNITY HALL. That any person or organization desiring the use of the Mills Community Hall, shall be required to restore the said Hall, following his, or their, occupancy, to a clean and orderly condition and shall pay for the privilege of its use a fee established as follows:

Girl or Boy Scout organizations	Free
Activities sponsored by any Mills church	Free
Affairs conducted for the benefit or entertainment of Mills children below the age of twelve years	Free
All other Mills organizations	\$1.00
Mills residents generally	1.00
All persons and organizations outside Mills	2.00
Certain charity affairs at discretion of Chairman	Free;

Provided that all persons and organizations shall be required when renting the Mills Community Hall, to deposit five (\$5.00) dollars with the Chairman or other member of the Board, as a guarantee of their compliance with this section, and that following the restoration of the said Hall to its original condition by the renter as herein required, the Chairman or other member of the Board with whom such deposit was made, shall thereupon refund the same; provided further that the Chairman of the Board shall keep a written record of all rentals of the said Hall, showing the person or organization to whom the said Hall was let and the date of ~~such~~ each such occupancy and the purpose thereof, together with any additional information pertinent thereto which he may deem worthy of reporting to his successor or to any other official of the town of Mills, and all such records shall be open for inspection by any member of the Board or any member of the Town Council and shall be preserved for a period of at least a year.

SECTION 2.-- THAT THIS ORDINANCE SHALL TAKE EFFECT AND BECOME IN FORCE AFTER ITS BEING POSTED UP FOR A PERIOD OF TEN DAYS, AS REQUIRED BY LAW.
